THE WIDOWS AND ORPHANS PENSION ORDINANCE

(Chapter 75).

UNDER SECTION 23 OF THE WIDOWS AND ORPHANS PENSION ORDINANCE, AS AMENDED BY THE WIDOWS AND ORPHANS PENSION (AMENDMENT) ORDINANCE, 1956, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:—

1. This Order may be cited as the Widows and Orphans Pension (Rates of Contribution) Order, 1962.

2. Subject to the provisions contained in the proviso to section 23 of the Widows and Orphans Pension Ordinance, as amended by the Widows and Orphans Pension (Amendment) Ordinance, 1956, the amounts shown in the second column of the schedule hereto shall for the purposes of the said Ordinance be deemed to be the maximum salaries of the officers on the scales set out in the first column of the said schedule.

3. The Widows and Orphans Pension (Rates of Contribution) Order, 1956*, is hereby revoked.

4. This Order shall come into operation on the 1st day of January, 1963.
