IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

Citation

1. This Order which amends the Trade (Control of Prices) Order* may be cited as the Trade (Control of Prices) (Amendment) (No. 4) Order 1979.
