IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

- 1. This Order which amends the Trade (Control of Prices) Citation Order\*, may be cited as the Trade (Control of Prices) (Amendment) (No. 11) Order 1979.

- (d) by the insertion in the respective columns of Part B of the Fourth Schedule thereto in relation to the articles numbered 72 (Bicycle Tyres) and 73 (Bicycle Tubes), of subdivisions (iii) and (iii) respectively and the particulars relating to those subdivisions specified in the respective columns of Part B of the Schedule to this Order.
