THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

1. This Order which amends the Trade (Control of Prices) Order\* Citation may be cited as the Trade (Control of Prices) (Amendment) (No. 12) Order 1979.

2. The Principal Order is hereby amended in the following respects —

- (a) by the substitution in Part A of the Fourth Schedule thereto, for the particulars specified in the respective columns of that Schedule in relation to the article numbered 33 (Instant Coffee) subdivision (vii), of the particulars specified in the respective columns of Part A of the Schedule to this Order in relation to the said subdivision; and
- (b) by the insertion in the respective columns of Part A of the Fourth Schedule thereto in relation to the article numbered 33 (Instant Coffee), of the subdivisions (x) and (xi) and the particulars relating to those subdivisions specified in the respective columns of Part A of the Schedule to this Order; and

Amendment of the Principal Order.

- (c) by the substitution in Part B of the Fourth Schedule thereto, for the particulars specified in the respective columns of that schedule in relation to the article numbered 33 (Instant Coffee) subdivision (vii), of the particulars specified in the respective columns of Part B of the Schedule to this Order in relation to the said subdivision; and
- (d) by the insertion in the respective columns of Part B of the Fourth Schedule thereto in relation to the article numbered 33 (Instant Coffee), of the subdivisions (x) and (xi) and the particulars relating to those subdivisions, specified in the respective columns of Part B of the Schedule to this Order.
