THE TRADE ACT

(Chapter 91:01)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER
BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOL-
LOWS:—

1. This Order, which amends the Trade (Control of Prices) Order*, may be cited as the Trade (Control of Prices) (Amendment) (No. 19) Order 1979. Citation.

2. The Principal Order is hereby amended — Amendment
of the

(a) by the insertion in clause 2 (1) thereof, immediately after the definition of "Georgetown and within one mile of the boundaries thereof", of the following definition —

"petrol filling station" means any place or premises in respect of which a licence is required to be taken out under section 61 of the Tax Act and includes any such place or premises where petroleum, and lubricants and accessories required for the repair of, or use in, motor vehicles, are sold, or any such place or premises where motor vehicles are kept temporarily for the purpose of being cleaned or washed or for the purpose of carrying out running repairs or, making minor adjustments, to them;" Chapter 80:01

- (c) by the substitution in Part B of the Fourth Schedule thereto, for the particulars specified in the respective columns of that Schedule in relation to the article numbered 4 (Petroleum Products), of the particulars specified in the respective columns of Part B of the Schedule to this Order in relation to the said article.
