THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT

(Chapter 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Upper Demerara Forestry Project, Port Site) Order 1979* made on the '22nd March, 1979, the proposed Construction of a Port Site on the land described in the Schedule to that Order was declared to be a public work in accordance with Section 3 of the _Acquisition of Lands for Public Purposes A,ct;

AND WHE'REAS, by the said Order the Chief Works officer together with his agents, servants or workmen was authorized under Section 4 of the said Act to enter upon the said land for the purpose of surveying or otherwise examining such land with a view to the acquisition of the whole or part thereof for the, construction of the public work aforesaid;

AND WHEREAS, in accordance with the provisions of Section 6 of the Act, the report of the Chief Works Officer and a plan of the land to be acquired have been laid before the Minister;

NOW THEREFORE, in accordance with the provisions of the said Section 6, it is hereby declared that the land described in the schedule to this Order is required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Upper Demerara Forestry Project, Port Site) (No. 2) Order, 1979.
