# THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT (Chapter 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Regional Hospital Berbice) Order 1979\* made on the 18th May, 1979, the proposed construction of a Regional Hospital on the land described in the Schedule to that Order was declared to be a public work in accordance with section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Chief Works Officer, together with his agents, servants or workmen, was authorised under section 4 of the Act to enter upon the said land for the purpose of surveying or otherwise examining such land with a view to the acquisition of the whole or part thereof fot the construction of the public work aforesaid;

AND WHEREAS in accordance with the provisions of section 6 of the Act, the report of the Chief Works Officer and a plan of the land to be acquired were laid before the Minister;

NOW THEREFORE, in accordance with the provisions of the said section 6 it is hereby declared that the land together with rights thereon described in the Schedule to this Order is required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Regional Hospital, Berbice) (No. 2) Order 1979.

#### **SCHEDULE**

That portion of land named Area 'D' (shown bordered red on plan 1 being part of Block 'C' and containing 27.872 acres (inclusive of the Detour Road Reserve) and compirising of the two plots of land named Plot 'A' (shown bordered brown on plan) and Plot 'B' (shown bordered green on plan) situate in the Sheet Anchor - Cumberland Local Government District on the right bank of the Canjie River on the East Sea Coast in the County of Berbice, Guyana, and described as follows-
