ORDER

MADE UNDER

THE LOCAL GOVERNMENT (VALUATION OF PROPERTY)
ORDINANCE 1959,

(No. 5 of 1959).

UNDER SECTION 5 OF THE LOCAL GOVERNMENT (VALUATION OF PROPERTY) ORDINANCE, 1959, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:—

1. This Order may be cited as the Local Government (Preparation of Valuation Lists) Order, 1963.

2. The date on which the valuation officer shall commence the preparation of the first list in the local government areas mentioned in Part I of the schedule hereto shall be the 19th day of January, 1963, and the date on which the aforementioned list shall come into operation shall be the 2nd day of January, 1965.

3. (1) The areas designated in the first column of Part II of the schedule hereto are hereby declared to be areas proposed to be amalgamated with the local authority mentioned in the second column of Part II of the said schedule.

(2) The date on which the valuation officer shall commence the preparation of the first list in the areas designated in the first column of Part II of the schedule hereto shall be the 19th day of January, 1963, and the date on which the aforementioned list shall come into operation shall be the 2nd day of January, 1965.
