THE EMERGENCY POWERS REGULATIONS, 1963.

(No. 7 of 1963)

WHEREAS it appears to the Governor that the services hereinafter referred to are essential to the life of the community and that it is necessary for maintaining those services to provide for the requisitioning of certain of the vehicles, tools and equipment hereinafter referred to, and that the persons referred to in article 6 of this Order should be directed to perform certain services;

NOW THEREFORE acting in accordance with paragraph (1) of article 22 of the Constitution of British Guiana and under regulations 2, 36 and 51 of the Emergency Powers Regulations, 1963, and by virtue of and in exercise of all other powers enabling him in that behalf it is hereby ordered by the Governor as follows:-

1. This Order may be cited as the Emergency Powers (Georgetown Sanitation), Order, 1963.

2. All cleansing, scavenging and sanitation services of the Mayor and Town Council of Georgetown (hereinafter referred to as "the Town Council") are hereby declared to be essential to the life of the community. The said services (hereinafter referred to as "the essential services") shall be deemed to be essential services within the meaning of regulation 2 of the Emergency Powers Regulations, 1963.

3. Subject to the provisions relating to compensation contained in regulation 37 of the Emergency Powers Regulations, 1963, where it appears to the Governor that any motor vehicles, tools or equipment in the ownership, possession, custody, control or management of the Town Council are capable of being used and are needed in connection with any of the essential services he may from time to time direct the Minister of Labour, Health and Housing (hereinafter referred to as "the Minister") to serve notice in writing on the Town Council requisitioning any such motor vehicles, tools or equipment as the case may be on behalf of the Governor.

4. With effect from the time when the notice has been served the motor vehicles, tools or equipment specified in the notice as having been requisitioned shall be deemed to have been duly requisitioned under this Order and may be used by the Minister or any persons whom he may authorise, in connection with any of the essential services.

5. Where it appears to the Minister that any motor vehicle, tool or equipment requisitioned under this Order is no longer needed he may after serving notice in writing to that effect on the Town Council cause that vehicle, tool or equipment as the case may be to be delivered to any officer or servant of the Town Council or, if that officer or servant refuses or neglects to accept delivery, cause that vehicle, tool or equipment as the case may be to be placed on or as near as may be reasonably practicable on any of the Town Council's premises, and thereupon the requisitioning of that vehicle, tool or equipment as the case may be shall come to an end.

6. Any notice which has to be served under this Order shall be deemed to have been duly served if left with any officer or servant of the Town Council.

7. (1) Dr. P.G. Barrow, Medical Officer of Health of the Town Council being a person who is ordinarily employed in or about the undertakings connected with the essential services, is hereby directed to remain and continue in his employment in or about such undertakings at his usual or ordinary remuneration until released by the Governor or the Minister.

(2) Each person named in the schedule hereto is hereby directed to undertake and perform in the City of Georgetown for the remuneration specified against his name and under the direction of the Minister the work or duties specified against his name.
