ORDER

MADE UNDER

THE TRADE ORDINANCE, 1958.

(No. 34 of 1958).

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:—

- 1. This Order may be cited as the Trade (Control of Prices) Order, 1963.
 - 2. For the purpose of this Order "actual cost" means
 - (a) in the case of a sale by wholesale, the value of the article as declared in the Customs Bill of Entry including duty with the addition of not more than 5 per centum; or
 - (b) in the case of a sale by retail the purchase price paid by the retailer; or
 - (c) where a wholesaler or retailer is unable to ascertain the cost to him of a price controlled article in the manner set out in either paragraph (a) or paragraph (b) of this article, such cost as may be fixed in writing by, or on behalf of, the Competent Authority;
 - (d) "deodorised coconut oil" means any oil manufactured from the kernel of the coconut and which has been subjected to any process or treatment whatsoever for removing the characteristic odour or flavour or acidity of the crude oil;

"Georgetown and within one mile of the boundaries thereof" means the City of Georgetown as defined by the Georgetown Town Council Ordinance* and any area within one mile of the boundaries thereof but does not include any land west of the Demerara River;

"price controlled article" means any article or thing the maximum price of which is for the time being controlled;

"wholesale" means the sale of any price controlled article to -

(a) any person whose premises are licensed or on which any licence duty is due and payable under the provisions of the Tax Ordinance† for the sale of any of the said articles to the public; or

- (b) any person who sells any of the said articles in a market licensed under the provisions of the Tax Ordinance*; or
- (c) a huckster licensed, or liable to pay licence duty, under the provisions of the Hucksters Licensing and Control Ordinance**; or
- (d) any person who in the conduct of the business of a bakery uses any of the said articles for the manufacture of bread for sale to the public.

"wholesaler" means any person who, either on his own behalf or on behalf of a principal, sells, offers to sell, exposes for sale or assists in the sale, of, any price controlled article by wholesale;

"retail" means the sale or disposal, other than by wholesale of any price controlled article;

"retailer" means any person who, either on his own behalf or on behalf of a principal, sells, offers to sell, exposes for sale or assists in the sale or disposal of any price controlled article by retail;

"North West District" means the North West District as proclaimed under the District Government Ordinance.

- 3. (1) This Order shall apply in those parts of British Guiana specified in the third schedule hereto.
- (2) Subject to the provisions of paragraph (3) of this article the maximum wholesale or retail price of any article specified in the first or second schedule hereto shall be the price specified therein against the name of that article or, if no price is so specified, the price arrived at according to the formula set out in either of the said schedules for determining the price of that article:

Provided that where the maximum price at which any article is to be retailed is based on an addition to the actual cost of a percentage of that cost and the retailer is also the importer of that article he may add the prescribed wholesale percentage, if any, to the actual cost before adding the retail percentage.

(3) Where in respect of any imported price controlled article of food-stuff specified in this Order a wholesaler sells to a retailer a smaller quantity than is contained in the package in which it is imported and this necessitates the wholesaler providing additional labour and an extra package or container, the wholesaler may add to the proportionate wholesale price of the article a sum not exceeding five per centum of such price:

Provided that such percentage shall not be added in the case of any canned or tinned goods.

- 4. (1) The retail selling prices of all price controlled articles sold, offered **or** exposed for sale, by retail shall be legibly marked thereon or otherwise indicated in plain figures for the information of the public.
- (2) The wholesale selling prices of all price controlled articles sold, offered or exposed for sale, by wholesale shall be legibly marked thereon or otherwise indicated in plain figures for the information of retailers and the public.
- (3) The owner or person in charge of any premises where any of the articles specified in the first schedule hereto is offered or exposed for sale shall display in a prominent position in or on the said premises a list showing clearly the maximum prices for the time being fixed in respect of such articles.

5. (1) No wholesaler or retailer shall for the purposes of his trade or business store any price controlled article on any premises or in any place other than his trade or business premises without the consent in writing of the Com-

petent Authority.

(2) No person shall permit any price controlled article to be stored on any premises or in any place in his possession or under his control in contravention of the provisions of the preceding paragraph.

- (3) The occupier or person in control of any premises or place in which price controlled articles of foodstuff are found in quantities exceeding his reasonable household requirements shall be deemed, in the absence of a reasonable explanation, to have contravened the provisions of paragraph (2) of this article.
- 6. (1) Every wholesaler or retailer shall keep full and complete records of his calculations of the actual cost and the maximum selling price of all price controlled articles exposed for sale or on display on his premises.
- (2) Every wholesaler or retailer shall file the invoices relating to all importations or purchases made by him in such manner that the records referred to in the preceding paragraph can be readily checked.
- (3) All goods to which this article applies which are exposed for sale by wholesale shall bear some mark by which entries relating to them in the records required to be kept under paragraph (1) of this article may be identified.
- (4) Every huckster licensed, or liable to pay licence duty, under the provisions of the Hucksters Licensing and Control Ordinance* shall produce on demand by any person authorised by the Competent Authority or any police officer or constable the invoices relating to the goods carried by him in any container, box, package or vehicle, or in any other manner whatsoever.
- 7. (1) No person carrying on a wholesale business which includes the selling for use or consumption in British Guiana of any price controlled article shall refuse without reasonable cause, to sell for cash by wholesale to any customer, being a retailer, the normal quantity of the said articles previously sold to him.
- (2) Whenever any wholesaler possesses a stock of any price controlled article of which there is otherwise a shortage in the local market, the Competent Authority may by order in writing require that wholesaler to sell to such retailer or retailers as shall be named in the order, the quantities therein specified of that article and upon tender of immediate payment of the maximum wholesale price of the quantities of the article so specified, that wholesaler shall sell such quantities in accordance with the order.

- 8. (1) Every wholesaler who sells or disposes of any price controlled article shall at the time of the sale or disposal supply the puchaser with an invoice or receipt or other similar document containing the particulars of the quantity and weight or measure of the articles sold and shall retain in his possession a duplicate of such invoice or receipt or other record of such sale.
- (2) Every invoice or receipt or other document made in pursuance of the preceding paragraph in respect of the sale or disposal of an imported price controlled article shall state the name or description of the article as it is mamed or described on the invoice or bill of lading relating to the importation thereof, and the quantity, and weight or measure, as well as the name and address of the purchaser.
- (3) Every invoice or receipt or other similar document made by a whole-saler in pursuance of paragraph (1) of this Article in respect of the sale of a price controlled article which has not been imported, shall state the name or description of the price controlled article as it is named or described in any control of prices order for the time being in force.
- 9. Every wholesaler of any articles of foodstuff the maximum prices of which are prescribed in the first schedule hereto, shall display in a prominent position, for the information of the public, in or on the premises in which he conducts his business, a list which names only those articles as aforesaid which he has in his possession or under his control.
- 10. Every retailer shall expose for sale items of all price controlled articles in his possession for the purposes of his trade or business.
- 11. (1) No person carrying on a retail business which includes the selling for use or consumption in British Guiana of any price controlled article shall refuse, without reasonable cause, to sell for cash to any customer the normal quantity of any of the said article previously sold to him.
- (2) For the purpose of this Order the owner of any retail business, his agent, clerk or other person in charge of that business or in attendance on customers, shall be deemed to be a person carrying on a retail business.
- 12. (1) Where a retail price in respect of any article is prescribed by this Order, no retailer shall sell a lesser quantity of any such article tham that in respect of which the price is prescribed:

Provided that —

- (a) where the prices of two quantities of any article are prescribed this paragraph shall apply to the lesser amount so prescribed,
- (b) where a purchaser asks for a lesser quantity than that specified, the retailer may sell such purchaser such lesser quantity.
- (2) If the purchaser requests the sale of any of the articles set out in the first schedule hereto in a lesser quantity than that specified in the said schedule and the proportionate amount of the maximum price as therein fixed includes a fraction of a cent, the wholesaler or retailer may, in the absence of agreement to the contrary, demand payment of one cent in respect of such fraction.

- 13. (1) No person shall sell, offer, or expose for sale, or buy any price controlled article at a price exceeding the maximum price prescribed by this Order, or im connection with a sale or disposition of any price controlled article, enter or offer to enter into any artificial or fictitious transaction or make or demand any unreasonable charge.
- (2) Except under and in accordance with the provisions of an Order made by the Competent Authority the imposition by the vendor of any condition in connection with the sale of any price controlled article is hereby prohibited.
- 14. The Competent Authority, any person duly authorised in writing by the said authority in that behalf, or any member of the Police Force duly authorised as aforesaid may enter and inspect any premises whatsoever for the purpose of ascertaining whether there has been any contravention of any of the provisions of this Order.

THIRD SCHEDULE

Parts of British Guiana to which this Order applies —

- That part of the North West District situated within thirty miles of the Atlantic Ocean and elsewhere in British Guiana situated within twentyfive miles of the Atlantic Ocean.
- 2. (i) The area within five miles of either bank of the Berbice River to the south of that part of British Guiana defined in paragraph 1 of this schedule and extending as far south as the junction of the Kibilibiri River with the Berbice River.
 - (ii) That part of the watershed between the Berbice River and the Demerara River known as the Ituni Settlement of the Demerara Bauxite Company Limited.
- The area within five miles of either bank of the Demerara River to the south of that part of British Guiana defined in paragraph 1 of this schedule and extending as far south as the junction of the Hibibia River with the Demerara River.

4. (i) The area within five miles of either bank of the Essequibo River to the south of that part of British Guiana defined in paragraph 1 of this schedule and extending as far south as the southern boundary of the Village District of Bartica.

(ii) All of the islands in the Essequibo River, north of the Village District of Bartica.
