ORDER

MADE UNDER

THE DRAINAGE AND IRRIGATION ORDINANCE,

(Chapter 192).

UNDER SECTION 23(5) OF THE DRAINAGE AND IRRIGATION ORDINANCE, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS :—

1. This Order may be cited as the Drainage and Irrigation (Construction) (No. 1) Order, 1963.

2. The Board shall cause to be constructed the drainage and irrigation works within the Park to Abary Drainage and Irrigation Area described in the schedule hereto

SCHEDULE

- (a) A distributary with dam on either side running eastwards on the northern side of the southern boundaries of Plantations Fellowship, Grove, Huntley, Airy Hall and Dundee, thence southwards on the eastern side of the sideline dam between Plantations Dundee and Novar and its southwards prolongation to the southern boundary of the Government reserve south of Plantation Novar and Grant 7163, thence eastwards on the northern side of the aforesaid southern boundary of the Government reserve south of Plantation Novar and Grant 7163, thence southwards on the eastern side of the west sideline dam of Plantation Recess and its southwards prolongation to the southern boundary of the Government reserve south of Licence of Occupancy A 112, thence eastwards on the northern side of the aforesaid southern boundary of the Government reserve south of Licence of Occupancy A 112 and its eastwards prolongation to the Burma Drain.
- (b) A 3 ft. diameter "Armco" controlled culvert under the Burma Road and railway line at the junction of the distributary with the Burma Drain south of Lease A 112 and its prolongation eastwards.
- (c) 18—2 ft. X 2 ft. greenheart irrigation outlet boxes on the northern dam of the distributary described at (a) above.
- (d) An irrigation supply canal along the southern boundary of Lease A 5010 and Licence of Occupancy A 10 extending westwards from the eastern boundary of Licence of Occupancy A 10 to the western boundary of Lease A 5010.
- (e) An irrigation supply canal with banks on either side along the prolongation westwards of the back or southern boundary of Lease A 5010 and extending westwards from the western boundary of Lease A 5010 to the west side of Licence of Occupancy A 115.

- (f) A drain on the Government reserve south of Licence of Occupancy A 115 between the prolongation southwards of the west and east sidelines of Licence of Occupancy A 115.
- (g) An Intake Box in the irrigation supply canal on the west sideline of Licence of Occupancy A 115 as described at (e) above.
- (h) An Outlet Box in the drain on the west sideline of Licence of Occupancy A 115 as described at (f) above.
- (i) A Heavy Duty Bridge across the irrigation supply canal described at (e) above and approximately in line with the middle walk of Plantation Catherine.
- (j) A Heavy Duty Bridge across the irrigation supply canal described at (e) above near the sideline of Licence of Occupancy A 115.
- ~~k) 4 - 2 ft. X 2 ft. greenheart irrigation outlet boxes on the north dam of the~~
supply canals described at (d) and (e) above.
