ORDER

MADE UNDER

THE AMERINDIAN ORDINANCE,

(Chapter 58)

UNDER SECTION 3 OF THE AMERINDIAN ORDINANCE, IN ACCORD-ANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS :--

1. This Order may be cited as the Amerindian Area (Amendment) Order, 1963, and shall be construed and read as one with the Amerindian Area Order, 1957*, hereinafter referred to as the Principal Order.

- 2. Article 2 of the Principal Order is hereby amended -
 - (a) by the deletion of the full stop at the end thereof; and
 - (b) by the insertion of the words "to be known as the Santa Rosa Amerindian Area" at the end thereof.

3. The schedule to the Principal Order is hereby revoked and the following substituted therefor —

"SCHEDULE

The Area situate within the North West Amerindian District as defined by the Amerindian Districts Order, 1953 (No. 59 of 1953), commencing at the mouth of the Cayman or Wainibaruka Creek, left bank Moruka River and extending thence in a south-westerly direction in a straight line to the mouth of the Cabura Creek. left bank Haimarakabra Creek, right bank Moruka River; thence upwards along the left bank of the Haimarakabra Creek to the mouth of the Barakara Creek; thence upwards along the left bank of the Barakara Creek to its source; thence in a north-easterly direction by a straight line to the south-western corner of Lot 88, Kumaka-Quebanna Road, as shown on a Plan by F. O. H. R. Pollard, Government Surveyor, dated 28th February, 1958, recorded in the Department of Lands and Mines as Plan No. 8277; thence along the western boundaries of Lots 88 and 87 and beyond in a straight line to the left bank Haimaruni Creek; thence downwards along the left bank of the Haimaruni Creek to its mouth at the right bank Biara River, thence downwards along the right bank of the Biara River to the mouth of the Bara-Bara Creek, thence from the mouth of the Bara-Bara Creek, in an easterly direction by a straight line to the source of the Cayman or Wainibaruka Creek; thence downwards along the left bank of the Cayman or Wainibaruka Creek bank to the point of commencement."
