## ORDER

# THE DRAINAGE AND IRRIGATION ORDINANCE (Chapter 192)

# UNDER SECTION 11(1) OF THE DRAINAGE AND IRRIGATION ORDI-NANCE, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTI-TUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS :--

1. The Drainage and Irrigation Board shall ascertain and determine whether the area described in the schedule hereto, or any part thereof, is suitable for and will be benefited by drainage and irrigation, or drainage or irrigation.

2. The daily newspapers in which this Order is to be published shall be the "Guiana Graphic" and the "Mirror".

## SCHEDULE

That area of land situated on the left bank of the Essequibo River between Onderneeming and Supenaam River bounded as follows :---

Commencing at the junction of the common boundary on the south between Plantation Adventure and Adventure Village with the left bank of the Essequibo River and extending southwards along the left bank of the Essequibo River to its junction with the right bank of the Supenaam River thence upstream along the 'right bank of the Supenaam River to a point 500 ft. west of the right bank of the Tapakuma Creek, a tributary of the Supenaam River, thence across the Supenaam River and along a line parallel to and distant 500 ft. west of the right bank of the aforesaid Tapakuma Creek, thence in a northwesterly and northerly direction along the watershed between the Arakuria River and the Ituribisi River to the source of the Ituribisi River thence in an easterly direction to the source of the Ikuraka River, and the source of the Towanama Creek and continuing in an easterly direction to the junction of the eastern edge of the Sand Reef aback of Plantations Maria's Lodge, Belfield and Onderneeming with the boundary between Plantations Maria's Lodge and Johanna Cecelia thence in a southerly direction along the aforesaid eastern edge of the Sand Reef aback Plantation Maria's Lodge, Belfield and Onderneeming to its junction with the boundary between Plantations Onderneeming and Adventure, thence in an easterly direction along the aforesaid boundary between Plantations Onderneeming and Adventure to its junction with the northwards prolongation of the common boundary on the west between Plantation Adventure and

Adventure Village, thence in a southerly direction along the aforesaid prolongation northwards of and the common boundary on the west between Plantation Adventure and Adventure Village to the common boundary on the south between Plantation Adventure and Adventure Village, thence in an easterly direction along the aforesaid common boundary on the south between Plantation Adventure and Adventure Village to its point of commencement.
