WHEREAS by the Acquisition of Lands for Public Purposes (Golden WHEREAS by the Acquisition of Lanus 101 ruple 1 triples of the 25th day Grove Community High School) Order, 1977 \* made on the 25th day Grove Community High School November, 1977 the proposed construction of a Community High School on the Lands described in the Schedule to that Order was declared to a public work in accordance with section 3 of the Acquisition of La for Public Purposes Act;

AND WHEREAS by the aforesaid Order the Chief Works Office together with his agents, servants or workmen was authorised in account with Section 4 of the Act to enter upon the said lands the surpose of surpose o the purpose of surveying or otherwise examining such lands with to the acquisition of the whole or part thereof for the construction of public work aforesaid;

AND WHEREAS in accordance with the provisions of section the Act, the report of the Chief Works Officer and a plan of the land be acquired have been laid before the Minister;

NOW THEREFORE, in accordance with the provisions of the section 6 it is hereby declared that the lands, described in the School to this Order, is required for the public work aforesaid.
