IN EXERCISE OF THE POWER CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

Citation.

1. This Order which amends the Trade (Control of Prices) Order * may be cited as the Trade (Control of Prices) (Amendment) (No. 22) Order 1978.

2. The Principal Order is hereby amended —
