IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 51 OF THE PETROLEUM (EXPLORATION AND PRODUCTION) ACT, 1986, I MAKE THE FOLLOWING ORDER:

Citation: 1. This Order may be cited as the Petroleum (Exploration and Production)

(Tax Laws) (Tullow Guyana B.V., Eco (Atlantic) Guyana Inc. and Total

E&P Guyana BV) Order 2019.

Interpretation: 2. In this Order –

"Agreement" means the Petroleum Agreement between the Government of the Cooperative Republic of Guyana of the one part and Tullow Guyana B.V. and Eco (Atlantic) Guyana Inc. of the other part, dated 14 January 2016 concerning the Orinduik Block, Offshore Guyana, which is a production sharing agreement;

"Licensees" means Tullow Guyana B.V., Eco (Atlantic) Guyana Inc. and Total E&P Guyana BV, including any of their permitted assignees and successors in interest. Any reference to one Licensee shall be a reference to all of them and vice versa.

Tax Laws: 3. For the purpose of giving effect to the Agreement, if so required by those provisions, the written laws mentioned in section 51(2) of the Petroleum (Exploration and Production) Act Cap. 65:04 or any part thereof shall not

apply to or in relation to the Licensees as at the date of this Order.
