### THE PUBLIC CORPORATIONS ACT 1988

(Cap 19:05)

**IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE PUBLIC CORPORATIONS ACT 1988, I MAKE THE FOLLOWING ORDER: -**

- Citation. 1. This Order may be cited as the National Industrial and Commercial Investments Limited (Transfer of Property) Order 2019.
- Interpretation. 2. In this Order -
- (a) "Agreement" means the Agreement of Sale and Purchase made on the 9<sup>th</sup> day of April 2019 between the NICIL and the Purchaser;
- (a) "NICIL" means the National Industrial and Commercial Investments Limited a company incorporated in Guyana under the Companies Act and continued under the Companies Act 1991, whose registered office is situated at 126 Barrack Street, Kingston, Georgetown, Guyana;
- Cap 89:01.
- (b) "Property" means the property described in the Schedule, being property belonging to NICIL;
- Schedule. (c) "Purchaser" means Badrudin Hassan of Lot 167 Hassan Street, Eccles, East Bank Demerara.
- Transfer of Property. 3. Pursuant to the Agreement and subject to the representations, covenants and the terms and conditions specified therein, the property is transferred to the Purchaser.
