Transfer of Property.

- (a) "Agreement" means the agreement made on the 6<sup>th</sup> day of September 2002 between the NICIL and the Purchaser:
- (b) "NICIL" means the National Industrial and Commercial Investments Limited, a company incorporated in Guyana under the Companies Act and continued under the Companies Act 1991. whose registered office is situate at 126 Barrack Street. Kingston. Georgetown. Guyana:
- (c) "Property" means the property described in the Schedule. being property owned by NICIL:

(d) "Purchaser" means Pritipaul Singh Investments Inc. a company incorporated in Guyana under the Companies Act 1991, whose registered office is situate at Mc Doom Wharf. East Bank Demerara. Guyana. Guyana.

3. Pursuant to the Agreement and subject to the representations. covenants and the terms and conditions specified therein, the Property is hereby transferred to the Purchaser.
