Interpretation.

- 2. In this Order -
  - (a) "Agreement" means the Agreement of Sale and Purchase entered into between the Company and the Purchaser on the 6<sup>th</sup> day of June, 2005 in relation to the Property.
  - (b) "Company" means NATIONAL INDUSTRIAL AND COMMERCIAL INVESTMENTS LIMITED, a company incorporated in Guyana under the Companies Act and continued under the Companies' Act 1991, whose registered Office is situate at 126 Parade and Barrack Street, Kingston, Georgetown, Guyana.
