THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT

(Cap. 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Ogle Aerodrome) Order 1994, No. 40 of 1994, made on the 14th September, 1994, the proposed construction of the Aerodrome and its associated facilities on the lands described in the Schedule to that Order was declared to be a public work in accordance with section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order, the Chief Works Officer, together with his agents, servants or workmen, was authorised under section 4 of the Act to enter upon the said lands for the purposes therein mentioned;

AND WHEREAS in accordance with the provisions of section 6 of the Act, the report of the Chief Works Officer together with plans of the lands to be acquired were laid before the Minister.

NOW THEREFORE in accordance with the provisions of section 6 of the said Act, it is hereby declared that the lands described in the Schedule to this Order are required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Ogle Aerodrome) (No. 2) Order 1995.

SCHEDULE

Firstly: Plot 'A' being a portion of Plantation Cummings Lodge, containing an area of 56.3324 (fifty-six decimal three three two four) acres.

Secondly: Plot being 'B' a portion of Area 'V' Plantation Cummings Lodge containing an area of 0.7170 (zero decimal seven one seven zero) acre.

Thirdly: Plot 'C' being a portion of Plantation Ogle and Plantation Industry containing an area of 199.153 (one hundred and ninety-nine decimal one five three) acres.

Fourthly: Plot 'D' being a portion of the Company Path between Plantation Cummings Lodge and Plantation Industry containing an area of 5.88 (five decimal eight eight) acres.

Sixthly: Plot 'F' being a portion of Plantation Industry and the Company Path between Plantation Industry and Plantation Cummings Lodge containing an area of 1.3860 (one decimal three eight six nought) acre all being situate on the East Coast of Demerara in the County of Demerara, Guyana.
