THE REPRESENTATION OF THE PEOPLE ACT

(Cap. 1:03)

IN EXERCISE OF THE POWERS CONFERRED UPON THE ELECTIONS COMMISSION BY SECTION 6 OF THE REPRESENTATION OF THE PEOPLE ACT THE ELECTIONS COMMISSION HEREBY MAKES THE FOLLOWING ORDER:—

1. This Order may be cited as the National Assembly Elections (Constitution of Polling Districts) Order 1992.

Citation.

2. (1) In partial modification of the Principal Order, it is hereby ordered that each of the ten polling districts into which Guyana is divided, and mentioned in column (1) the Schedule, shall consist of the polling divisions mentioned against it in column (2) thereof.

Modification of amendment of the Schedule to the Principal Order.

(2) The Schedule to the Principal Order is hereby amended by the substitution for the words "twenty", "thirty-eight", "one hundred and fifteen", "two hundred and seventy-five", "sixty-four", "one hundred and thirty-two", "thirty-four", "thirteen", "twenty-three", and "fifty-four", of the words "ninety-one", "sixty-one", "one hundred and eleven", "one hundred and fifty-five", "eighty-one", "one hundred and eighty-eight", "ninety-nine", "forty-six", "seventy-three", and "sixty-one", respectively.

3. The National Assembly Elections (Constitution of Polling Divisions) Order 1985 is hereby revoked.
