IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 8 AND 11 OF THE PUBLIC CORPORATIONS ACT 1988, AS APPLIED TO THE GUYANA STOCKFEEDS LIMITED BY NOTIFICATION UNDER SECTION 66 OF THAT ACT, I HEREBY MAKE THE FOLLOW-ING ORDER:--

1. This Order may be cited as the Guyana Stockfeeds Limited (Transfer of Property) Order 1992 and shall be deemed to have come into operation on 21st September, 1992.

 - (c) "Company" means the Guyana Stockfeeds Limited, being a company incorporated under the Companies Act and whose office is situated at Farm, East Bank Demerara;
 - (d) "property" means the property described in the Schedule, being property belonging to the Company;
 - (e) "Purchaser" means Mr. Junior Sampson of Susannah's Rust, West Bank Demerara.

3. Pursuant to the Agreement and subject to the terms and conditions specified therein, the property is hereby transferred to the Purchaser with effect from the appointed day.
