IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE CONSTITUTIONAL OFFICES (REMUNERA-TION OF HOLDERS) ACT, I HEREBY MAKE THE FOLLOWING ORDER:-

1. This Order may be cited as the Constitutional Offices (Remuneration of Holders) Order 1994.

Citation,

2. The Schedule to the Act, in relation to the annual rates of salaries for the specified offices, is hereby amended as follows —

- (a) the rates of salaries as at 31st December, 1992 are increased by twenty per cent from 1st July, 1993, the said increase being tax free from 1st July, 1993 to 30th April, 1994, and tax shall be paid thereon from 1st May, 1994, but the rates of salaries in respect of those persons who are liable to pav tax thereon shall be increased from 1st Mav, 1994 by such sum as may be necessary for the said increase of twenty per cent to amount to a net increase of twenty per cent after deduction of tax;
- (b) the rates of salaries as at 30th June, 1994 are increased from 1st July, 1994 by five per cent.

3. The Constitutional Offices (Remuneration of Holders) (No. 2) Order 1993 is hereby revoked with effect from 1st July, 1993 and the advances made thereunder for the period from — of the Schedule to the Act,

EXPLANATORY NOTE

(This note is not part of this Order)

This Order amends the Schedule to the Constitutional Offices (Remuneration of Holders) Act, Cap. 27:11.

Clause 2(a) increases from 1st July, 1993 the respective annual rates of salaries as at 31st December, 1992 by twenty per cent, tax free, for the period 1st July, 1993 to 30th April, 1994 and from 1st May, 1994 by such sum as may be necessary for the said increase of twenty per cent, after deduction of tax, to be a net increase of twenty per cent.

Clause 2(b) increases from 1st July, 1994 the said salaries as at 30th June, 1994 by five per cent.

Clause 3 revokes the Constitutional Offices (Remuneration of Holders) (No. 2) Order 1993 and provides for the disposition of the twenty per cent advance made thereunder.
