# Made Under THE TRADE ACT

(Cap. 91:01)

## IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

Citation

1. This Order, which amends the Trade (Control of Prices) Order\*, may be cited as the Trade (Control of Prices) (Amendment) (No. 11) Order 1980.

Amendment of the Principal Order. 2. The Principal Order is hereby amended -

- 1.   - (b) by the insertion in the respective columns of Part B of the Fourth Schedule thereto in relation to the article numbered 5 (Powdered Milk) of the particulars specified in the respective columns of Part B of Schedule II to this order in relation to the said article.
