THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT
(Cap. 62:05)
IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 3 AND 4 OF THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT, I HEREBY MAKE THE FOLLOWING ORDER:-

1. This Order may be cited as the Acquisition of Lands for Public Purposes (Construction of 69 KV Transmission Line from Plantation Providence, East Bank Berbice to No. 53 Village, Corentyne) Order 1980.
2. The proposed construction of a 69 KV Transmission Line on the lands described in the Schedule hereunder is hereby declared to be a public work.
3. The General Manager of the Guyana Electricity Corporation; together with his agents, servants or workmen, is hereby authorised to enter upon the said lands for the purpose of surveying or otherwise examining such lands with a view to the acquisition of the whole or part of such lands for the public work aforesaid.

## SCHEDULE

A strip of land 100 feet wide extending from the common boundary between Rotterdam and Belle Vue on the right bank of the Berbice River to the common boundary between Nos. 53 and 54 Villages on the left bank of the Corentyne River.

The inner and outer boundaries of the said strip of land are located at the distances from the centre line of the appropriate public roads given in the Table below and are straight stretches between the common boundaries of the intervening villages listed in the said Table.
