IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

1. This order which amends the Trade (Control of Prices) Citat Order*, may be cited as the Trade (Control of Prices) (Amendment) (No. 17) Order 1980.

2. The Principal Order is hereby amended —
