THE NATIONAL REGISTRATION ACT, 1967
(No. 24 of 1967)

UNDER SECTION 19 OF THE NATIONAL REGISTRATION ACT, 1967,
THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE
MINISTER:—

1. These Regulations which amend the National Registration Regulations, 1968* may be cited as the National Registration (Amendment) (No. 2) Regulations, 1973.

2. The provisions of the Principal Regulations as are specified in the first column of the Schedule are hereby amended to the extent set out in the second column thereof.

- (a) Delete paragraph (1) and the proviso thereto.
- (b) In paragraph (2) substitute for all the words appearing after the word "on" the words "the second day following that on which directions have been given under section 14 for the preparation of the lists" and renumber the said paragraph as regulation 10.

- (a) Substitute for sub paragraph (a) (ii) of paragraph (1) the following —
- “(ii) by reason of his having such qualifications as render him eligible for registration.”
- (b) Delete from paragraph (2) the words “pursuant to the relevant

order mentioned in paragraph (1) of regulation 4.”.

Renumber paragraph (3) as paragraph (4) and insert immediately before that paragraph the following paragraph—

“(3) Notwithstanding anything to the contrary in paragraphs (1) and (2) a claimant referred to in paragraph (1) (a) of regulation 11 who had not made an application shall deliver his submission to the Registration Officer for transmission to the Deputy Commissioner and at the time of delivery do all such things as are required of a person making an application under regulation 4 and the provisions of paragraphs (2) and (3) of that regulation and of regulations 6 and 7 shall, subject to the effect of the decision on the submission, apply mutatis mutandis in respect of anything to be done by the claimant by virtue of this paragraph.”

- (a) Substitute in paragraph (1) for the words “by paragraph (2) of” the word “by”.
- (b) Substitute for the word “fourteen” the word “two”.
- (c) Substitute for the word “third” wherever it appears the word “first”.

15 (2)

Substitute for the word “three” the word “two”.

23

Substitute the following for regulation 23 —

“23. The Commissioner shall revise the list by way of the annexation thereto of supplementary lists in such form as determined by the Commissioner containing all such changes and additions to the list as are necessary from time to time by virtue of the final determination of claims and objections and a supplementary list, together with the list, shall constitute the revised list as at the date of the latest of such supplementary list.”
