THE CUSTOMS ACT

(Cap. 82:01)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 275 OF THE CUSTOMS ACT, I HEREBY MAKE THE FOLLOWING REGULATIONS:—

Citation.

1. These Regulations which amend the Customs Regulations* may be cited as the Customs (Amendment) Regulations 1974.

Amendment of the Principal Regulations 2. The Principal Regulations are hereby amended —

(a) by the substitution in the General Note to Schedule D thereto, for the words "13½ inches by 8½ inches" of the words —

"15 inches by 9 inches"; and

(b) by the substitution for the specimens of customs forms contained in Schedule D thereto and respectively numbered C 19, C 20, C 21, C 22, C 23, C 24, C 30, C 31, C 33, C 34, C 35, C 36, C 40 and C 41 of the specimens of customs forms contained in the Schedule hereto and of the same respective numbers.
