Made Under

THE MOTOR VEHICLES AND ROAD TRAFFIC ACT (Chapter: 51:02)

UNDER SECTION 103 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT, THE FOLLOWING REGULATIONS ARE HEREBY MADE:—

1. These Regulations may be cited as the Motor Vehicles and Road Traffic (Regulations of Premises and Register of Repairs and Sales) Regulations 1975.

2.(1) An application for registration of premises pursuant to section 63 of the Act shall be made in the form numbered 1 in the Schedule to the Licensing Officer at the police station to which a report would be required to be made by the occupier of the premises for the purposes of section 63(4) of the Act.

(2) Every Certificate of registration shall be in the form numbered 2 in the Schedule and shall be valid for a period of one year from the date of issue.

(3) Upon the issue of a certificate of registration the applicant therefor shall pay a fee of twenty-five dollars (\$25.00).

3. The book required to be kept for the purposes of section 63 of the Act shall show —

- (a) the address of the premises and the name of the owner or occupier thereof;
- (b) the date of receipt, the registration number, colour and make of any motor vehicle brought to the premises to be sold or for repairs to be carried out on the body thereof;
- (c) the name and address of the owner of the vehicle mentioned in paragraph (b) and the name, address and signature of the person who brought the vehicle un'o the premises or at whose request the vehicle was brought;

- (d) the nature and extent of the repairs to be carried out on the body of the vehicle and the circumstances that made necessary such repairs;
- (e) the date and the place at which, or persons to whom, any report was made pursuant to section 63(4) of the Act and the name of the person making such report.

4. A report of the repairs to be effected on a vehicle for the purposes of section 63(4) of the Act shall be in the form numbered 3 in the Schedule.

5. The certificate for the purpose of evidencing the fact that the damage shown on a vehicle has been the subject matter of police enquiries, as mentioned in Section 63(8) of the Act, shall be in the form numbered 4 in the Schedule.
