REGULATIONS

Made Under

THE POST AND TELEGRAPH ACT

(Cap. 47:01)

BY VIRTUE AND IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 63(5) OF THE POST AND TELEGRAPH ACT, I HEREBY MAKE THE FOLLOWING REGULATIONS:—

1. These Regulations may be cited as the Wireless Telegraphy (Amendment) Regulations 1976 and shall come into operation on 1st January, 1977.

2. The provisions of the Principal Regulations set out in the first Schedule column of the schedule are hereby amended in the manner and to the extent set out in the second column thereof.

Regulation 3

Substitute the words "General Manager of the Corporation" for the word "Minister" wherever it occurs.

Regulation 6

Substitute the words "the General Manager of the Corporation or to such persons as may be authorised by him for the purpose" for the word "Minister."

Regulation 8 Substitute the words “General Manager of the Corporation” for the word “Minister”.

Regulation 24 Substitute for the word “Minister” the words “General Manager of the Corporation in the case of Broadcast Receiving Licences, and the Minister in the case of Amateur Licences.”.

Regulation 26 Substitute the following regulation for regulation 26 —

“Breach 26.(1) The Minister or the General

licence. Manager of the Corporation
may cancel or suspend any
licence granted by the Minis-
ter or the General Manager,
as the case may be, where any
licensee has been convicted
of an offence against these
Regulations or the Act or
where in the opinion of the
Minister, or the General Man-
ager, a licensee has failed to
observe any of the provisions
of the Act or these Regula-
tions or any of the terms or
conditions of the licence.

(2) Where any licence is can-
celled for breach of these
Regulations or of the Act or
of the terms or conditions of
the licence, the licensee shall
not be eligible for the grant
of any licence for a pe iod of
twelve months or such further
period as the Minister or the
General Manager, as the case
may be, may direct that any
such licensee be debarred
from working or operating
any apparatus.”

Regulation 29(1) Substitute the number “16” for the number “18”.

Regulations 35 and 36 Substitute the words “General Manager of the Corporation” for the words “Postmaster General”.

- Regulation 37** Substitute the words “General Manager of the Corporation or duly authorised officers of the Corporation” for the words “Postmaster General or duly authorised officers of the Post Office Department”.
- Regulation 42** Insert the words “or the General Manager of the Corporation, as the case may be,” immediately after the word “Minister”.
- Regulation 44** Substitute for the word “Minister” the words “General Manager of the Corporation in the case of broadcast receiving sets, and the Minister in the case of any other apparatus.”
- Regulation 45** Substitute for the word “Minister” the words “General Manager of the Corporation in the case of a broadcast receiving set, and the Minister in the case of any other apparatus.”
- Regulation 47** Substitute the following paragraph for paragraph (b) —
- “(b) obstruct the Minister or the General Manager of the Corporation or the Postmaster General or any officer acting under the instructions of any of them or in the performance of their functions under these Regulations;”
- Schedule A (Form of Broadcast Receiving Set Licence) (including regulation 6 reproduced on the said Form) (Form of Broadcast Receiving Set Licence)** Substitute the words “General Manager of the Guyana Telecommunication Corporation” for the words “Minister”, “Postmaster General”, “Engineer in Chief, Post Office Telecommunications” and “Engineer in Chief”, respectively.
- Schedule A (Regulation 35 reproduced on the Form of the Broadcast Receiving Set Licence)** Substitute the words “General Manager of the Guyana Telecommunication Corporation” for the words “Postmaster General”.

- (a) Substitute the words "General Manager of the Guyana Telecommunication Corporation" for the words "Postmaster General";
- (b) Substitute the words "Guyana Telecommunication Corporation" for the words "Post Office Department".

SCHEDULE C

- (a) Substitute the words "General Manager, Guyana Telecommunication Corporation" for the words "Engineer in Chief, Post Office Telecommunications".
- (b) In condition 10, substitute "8R" for "VP3".
- (c) In condition 11, substitute the words "Guyana Telecommunication Corporation" for the words "Post Office".

SCHEDULE D

Substitute the words "General Manager of the Guyana Telecommunication Corporation" for the words "Postmaster General".
