## SCHEDULE - FORMS

Citation.

1. These Regulations, which amend the National Registration (Residents)
Regulations, may be cited as the National Registration (Residents) (Amendment)
Regulations 2005.

Amendment of regulation 2 of the Principal Regulations.

- 2. (1) Regulation 2 (1) of the Principal Regulations is hereby amended as follows-
  - (a) by the insertion of the following definitions in their appropriate alphabetical order
    - "central register" means the national register of registrants data base established under section 9 of the Act;
    - "continuous registration" means an ongoing process for updating the national register of registrants data base on a daily basis;
    - "signature" means a person's name written by himself, and if he cannot write, includes any mark or thumb impression;
  - (b) by the substitution for the definition of the words "registration office" of the following definition
    - "registration office" means the office of a registration officer or an assistant registration officer.
- (2) Regulation 2 (2) of the Principal Regulations is hereby amended by the substitution for the word "card" of the word "record".

Amendment of regulation 3 of the Principal Regulations.

3. Regulation 3 (3) of the Principal Regulations is hereby amended by the substitution for the word "registrar" of the words "registration officer" and by the substitution for the word "district" wherever it appears, including the marginal note of the words "registration area".

Amendment of regulation 4 of the Principal Regulations.

4. Regulation 4 (1) of the Principal Regulations is hereby amended by the substitution for the word "Registrars" of the words "Registration Officers" and for the words "deputy registrar or divisional registrar" of the words "assistant registration officer".

Amendment of regulation 5 of the Principal Regulations.

5. Regulation 5 of the Principal Regulations is hereby amended by the substitution for the word "registrar" of the words "registration officer".

Amendment of regulation 6 of the Principal Regulations.

6. Regulation 6 of the Principal Regulations is hereby amended by the substitution therefor of the following regulations –

"Registration of persons.

6.(1) A registration officer shall tender application forms and receive applications from eligible persons:

Provided that applications for the registration of persons referred to in proviso (a) to section 6(4) of the Act and who are resident at the qualifying date in any registration division may be made to the registration officer therefor, who shall furnish application forms to such applicants, at the office established for the purpose under that proviso.

- (2) Every person making any such application as aforesaid shall -
- (a) furnish the particulars regarding himself as at the qualifying date which are required for the purpose of completing Form R 01;

Form R 01

- (b) furnish such documentary or other proof of any of the particulars referred to in sub-paragraph (a), including his birth certificate, as the registration officer may in any particular case reasonably require to satisfy himself of the truth thereof;
- (c) comply with such requirements of the registration officer as may be reasonably necessary for the

measurement and recording of his height;

- (d) comply with such requirements of the registration officer as may be reasonably necessary for the taking and recording of his finger prints as may be determined by the Commission;
- (e) answer any questions which the registration officer may in any particular case, reasonably consider necessary to put for the purpose of enabling him to decide whether the applicant is eligible to be registered as resident in the registration officer's registration division at the qualifying date.
- (3) Every application under this regulation shall -

Form R 01

- (a) be in Form R 01;
- (b) be in triplicate;
- (c) subject to paragraph (4), be completed on the part of the applicant in the presence of the registration officer and scrutineers, if the scrutineers are present;
- (d) subject to regulation 10, be signed by the applicant; and
- (e) have a printed serial number,

and the applicant shall be classified therein as Category A, in any case where his particulars are such as to qualify him for electoral registration as mentioned in section 14(1) of the Act, and as Category B in any other case.

(4) The process of continuous registration under section 6 of the Act shall be conducted every working day as may be determined by the

Commission.

Investigation by registration officer.

- 6A.(1) A registration officer, before registering any person as an elector, may require that person to produce a certificate of naturalisation, registration or other proof that he is either a citizen of Guyana or a citizen of a Commonwealth country domiciled and resident in Guyana.
- (2) The registration officer may require any applicant for registration to give him such further information as will facilitate him in the discharge of his functions under these Regulations.
- (3) The registration officer shall, subject to directions of the Commissioner, cause investigations to be made and hold enquiries as he deems necessary to satisfy himself as to the applicant's eligibility or otherwise to be registered as an elector, and for that purpose, he may summon witnesses or order the production of any document that he may deem necessary and receive and record any evidence adduced.
- (4) The registration officer may conduct an investigation into the facts set out in each application received by him in Form R 02 to verify the residency and identity of the applicant.
- (5) Where the registration officer is satisfied that the applicant is eligible to be registered, the registration officer shall prepare an application in triplicate in Form R 01 to be signed by the applicant.
- 6B.(1) The registration officer shall, as soon as may be practicable, forward in the manner directed by the Commissioner the original and duplicate of registration records with photographs affixed.

Form R 02

Form R 01

Submission of completed documents.

- (2) On receipt of the documents referred to in paragraph (1), the Commissioner shall
  - (a) ensure that the particulars are validated before the information is encoded;
  - (b) thereafter cause the national identification card to be produced; and

Form R 01

(c) file the original Form R 01 as part of the official records.

Form R 01

- (3) The duplicate of the application for registration, Form R 01, shall be returned and shall be maintained in the office of the registration officer in alphabetical order according to surnames within registration divisions.
- (4)The national identification card in respect of each applicant shall be prepared by the Commissioner and shall bear his facsimile signature.
- (5) Every national identification card shall bear a serial number and such other identification features necessary to identify the applicant as the person whom he claims to be, and such identification features may be in the form of the applicant's facial photograph, facsimile signature or an imprint of the applicant's left thumb.

Preparation of monthly list.

6C. The registration officer as directed by the Commissioner shall publish a monthly supplementary list of all the persons who make claims to entry in the preliminary list, corrections of particulars and requests for transfer by posting such list in their respective offices and within each registration division.

Merger of list to establish the preliminary list. 6D. The Commissioner shall within the prescribed time, merge the monthly supplementary lists with the official list which was used to commence continuous registration.

Preparation of preliminary list.

6E. The Commission shall direct the preparation of the preliminary list and the conduct of claims and objections in accordance with sections 14 and 15 of the Act.".

Amendment of regulation 7 of the Principal Regulations.

7. Regulation 7 of the Principal Regulations is hereby amended by the substitution therefor of the following -

"Allowance, and disallowance in respect of registration.

. 7. (1) If a registration officer, on receipt of an application for the registration of any person in reference to his registration area, is satisfied that there is no previous application by that person for such registration with reference to the qualifying date the application in Form R 01 so received may be granted.

Form R 01

(2) If the registration officer is not satisfied as mentioned in paragraph (1) he shall cancel the person's application by writing thereon the word "disallowed", issue to him a notice of disallowance in Form R 06 where his reasons for the disallowance shall be set out.

Form R 06

(3) Any person who is aggrieved by the decision of the registration officer under paragraph (2) may within ten days from the date of the notice of disallowance, tender a notice of appeal, to the Commissioner on Form R 07 through the registration officer."

8. Regulation 8 of the Principal Regulations is hereby revoked.

Revocation of regulation 8 of the Principal Regulations.

Amendment of regulation 9 of the Principal Regulations.

- 9. Regulation 9 of the Principal Regulations is hereby amended as follows
  - (a) by the substitution for the words "divisional registrar" of the words "registration officer" wherever they appear and for the word "card" and "cards" wherever they appear of the word "record" and "records", respectively.
  - (b) by the substitution for paragraph (3) of the following –

"(3) Subject to regulation 18, the registration officer shall give the triplicate of the completed Form R 01 to the registrant.

Amendment of regulation 10 of the Principal Regulations.

10. Regulation 10 of the Principal Regulation is hereby amended by the substitution therefor of the following -

"Persons unable to read or write or otherwise incapacitated.

Form R 01

10.(1) Where a person is unable to read the entries in Form R 01, the registration officer shall read over to him, before such witness (if any) of his choice as is present, the contents of the registration record for the purpose of ensuring that the contents are true and correct.

- (2) Where the person is unable to sign his name, the registration officer shall take and record, in place of such signature, the person's left thumb print or, if that is not practicable, some other single finger print with a note indicating which of the person's other fingers is so printed, and shall initial that print; and the person shall comply with such requirements of the registration officer as may be reasonably necessary for the purpose.
- (3) If by reason of any physical defect or injury it is impracticable to comply with any requirement that some finger of a person (other than his left thumb) be printed under the foregoing provisions of these Regulations, the registration officer shall enter and sign a note to that effect, and of the reason, in place of such print."

Revocation of regulation 11 of the Principal Regulations.

11. Regulation 11 of the Principal Regulations is hereby revoked.

Amendment of regulation 12 of the Principal Regulations.

12. Regulation 12 of the Principal Regulations, including the marginal note, is hereby amended by the substitution for the words "divisional registrar" of the words "registration officer" wherever they occur and for the word "card" of the word "record" wherever it occurs.

Amendment of regulation 13 of the Principal Regulations.

13. Regulation 13 of the Principal Regulations is hereby amended by substitution therefor of the following regulation –

"Correction of mistakes.

- 13. (1) Any clerical or other error or omission in the registration record of any person which has been caused by inadvertence may be corrected or supplied by way of the requisite alteration being made thereto by the registration officer of the registration area where the person's registration was made or effected, as the case may be.
- (2) Every alteration made pursuant to this regulation by a registration officer shall be signed by him; the alteration shall be signed by the person to whom the record relates, who shall, in addition, sign such corresponding alteration to the duplicate and triplicate of the record (as the case may be).
- (3) Regulation 10 shall apply *mutatis mutandis* in relation to alterations made by a registration officer under this regulation and their signing by the said person as that regulation applies in relation to the contents of a form to which it refers and signature thereof.
- (4) Where the registration officer makes any alteration under this regulation, he shall give to the said person notice thereof, which may be sent by registered post to his last known address.

(5) Reference in the foregoing provisions of this regulation to the making by the registration officer of any alteration to a registration record shall be construed to include reference to his making the same in his files or divisional register, and to his causing it to be made by way of notification to the Commissioner under the next following paragraph, to the original, duplicate and any triplicate thereof.

- (6) Upon notification of any alteration by a registration officer pursuant to this regulation, to any original or copy of the relevant registration record which is kept by him; and the Commissioner, instead of the registration officer (notwithstanding the provisions of any regulation), shall sign every alteration made under this paragraph.
  - (7) Where the description of the address of any person has been altered by lawful authority, the foregoing provisions of this regulation shall apply to any resulting inaccurate address in his registration record as they apply to any error mentioned in paragraph (1).".

Amendment of regulation 14 of the Principal Regulations.

- 14. Regulation 14 of the Principal Regulations is hereby amended by the substitution-
  - (a) for the word "card", wherever it appears, of the word "record";
  - (b) for the word "registrar", wherever they appear, of the words "registration officer";
  - (c) for the words "Form 5" of the words "Form R 03"; and
  - (d) for the words "Form 5", where it appears in the marginal note, of the words "Form R 03".

Amendment of the Principal Regulations. 15. The Principal Regulations are hereby amended by the insertion immediately after regulation 14 of the following regulations —

"Change of place of residence.

- 14A.(1) An elector who has changed his place of residence from one address to another shall give notice of such change of residence in
- Form R 0 4. Form R 04 to the registration officer of the division concerned.
  - (2) Upon receipt of a notice referred to in paragraph (1), the registration officer shall, if he is satisfied as to the identity of the person giving the notice and the correctness of the other particulars contained therein, make such arrangements for the change to be verified in accordance with Form R 02.

Form R 02.

- (3) The registration officer shall cause an investigation to be made in connection therewith, and upon receipt of any report thereon, he shall, if he is then satisfied, validate the application.
- (4) The registration officer after validating the application shall, forward the validated application to the Commissioner who shall make the necessary adjustment to the registration record of such person in the central register and publish such change.

(5) Where a registered person changes his place of residence from

one division to another, he shall give written notice thereof in

Form R 04

Form R 04 to the registration officer of the area in which he now resides as a result of his change of residence and thereupon, if the registration officer is satisfied of the correctness of the particulars in the notice, the registration record of such person shall be transferred to the divisional register for that division in which he resides:

Provided that no elector may be transferred from one

divisional register to another divisional register at any time after the National Assembly has been dissolved.

(6) Where a person who is registered as an elector for a division has ceased to reside in that division, he shall not on that account cease to be qualified to vote in that division unless and until his registration record has been transferred from there to another division.

Change of name or other particulars.

14B.(1) Where a registered person changes his name or other particulars in a manner recognised by the law for the time being he shall –

Form R 03

- (a) give notice thereof in Form R 03 to the registration officer of the division in which he is registered;
- (b) produce to the registration office satisfactory evidence of such change; and
- if necessary, surrender to the registration officer his national identification card.

(2) If the registration officer is satisfied as to the identity of the person giving the notice or as to his change of name or other particulars, he shall forward the completed Form R 03 with the supporting documentation to the Commissioner for final validation and adjustment of the central register and the preparation of a new national identification card where applicable.

Form R 03

- (3)Where, following upon an investigation made under paragraph(2), the registration officer is not satisfied -
  - (a) that the person giving notice of a change of name or other particulars is in fact the person to whom the

national identification card surrendered by him belongs; or

- (b) that there has in fact been any legal change of name, he shall refuse to make any amendment in the record of the elector concerned and shall return the national identification card to the person legally entitled to it;
- (c) that there has in fact been any change to particulars other than name.".

Amendment of regulation 15 of the Principal Regulations.

- 16. (1) Regulation 15 (1) of the Principal Regulations is hereby amended as follows-
  - (a) by the substitution for the words "divisional registrar" and the word "registrar", wherever those words appear, of the words "registration officer";
  - (b) by the substitution in regulation 15 (1) (b) for the word "cards" of the word "records"; and
  - (c) by the substitution of the marginal note therefor of the following marginal note -

"Documents to be safely kept by registration officer."

- (2) Regulation 15 (2) of the Principal Regulations is hereby amended by substitution therefor of the following-
  - "(2) The Commission may direct that all cards, forms and other documents that have been received, completed or otherwise used by the registration officer, in the performance of his duties and all such documents

which were required to be treated by him in the manner provided by the preceding paragraph shall be safely kept."

Amendment of regulation 16 of the Principal Regulations.

- 17. Regulation-16 of the Principal Regulation is hereby amended as follows-
  - (a) by the substitution of the words "divisional registrar", wherever they appear, of the words "registration officer"; and
  - (b) by the insertion of the word "records", immediately after the words "the applicants' registration",
  - (c) by the substitution for the marginal note of the following –

    "Performance of one registration officer's functions by another.".

Amendment of regulation 17 of the Principal Regulations.

- 18. Regulation 17 of the Principal Regulations is hereby amended as follows-
  - (a) by the substitution for the words "card" and "divisional registrar", wherever they appear, of the words "record" and "registration officer", respectively;
  - (b) by the deletion in paragraph (1) of the words beginning with "within" and ending with "direction";
  - (c) by the substitution for the words "official photographer" and "photographer" wherever they appear of the words "registration officer";
  - (d) by the deletion of paragraph (5);
  - (e) by the substitution in paragraph (6) for the words beginning with "photographer" and ending with "registrar" of the words "registration officer";

- (f) by the insertion immediately after paragraph (6) of the following paragraph-
  - "(7) Where a photograph of an applicant has been spoilt, lost or damaged, the registration officer may by notice in Form R14 require him to have his photograph retaken as many times as may be necessary to obtain a satisfactory photograph of that person."

Amendment of regulation 18 of the Principal Regulations.

19. (1) Regulation 18 of the Principal Regulations is hereby amended by the substitution therefor of the following regulation –

Exemption from taking of photograph.

Form R 14

18. (1) Where a registrant objects to the taking of his photograph for the reason that his face is disfigured or on any other grounds he may apply for exemption from compliance with the requirements of regulation 17.

Form R 15

- (2) An application under this regulation shall be in Form R 15 and shall be tendered to the registration officer.
- (3) On receipt of such application the registration officer shall determine whether the application shall be granted or refused.
- (4) If the registration officer grants the application he shall endorse on the application and the registration record of the registrant the words "Exempted from being photographed" together with his signature and shall record the reason for such exemption.

Amendment of regulation 19 of the Principal Regulations.

- 20. Regulation 19 of the Principal Regulations is hereby amended as follows-
  - (a) by the substitution in paragraph (1) for the words "The Minister may,

in his discretion" of the words "The Commission may, in its discretion";

  - "(4) The registration officer shall endorse on the registration record of a person exempted under this regulation the words "Exempted from being photographed", together with his signature."

- 20. (1) A registration officer shall, at such times as the Commissioner may direct, transmit to the Commissioner, who shall treat in like manner as provided by regulation 15 (1), the original registration records completed by the registration officer in the performance of his duties under these Regulations and such duplicate copies of registration records as he may have so received under regulation 15 (2) and by virtue of regulation 18.
- (2) The Commissioner having received the documents mentioned in paragraph (1) and, where a photograph has been taken in

respect of any person shall cause to prepare the person's national identification card from the particulars on his registration record and photograph attached:

Provided that where such person's age determined under the proviso to regulation 6(2)(b) had been entered on his registration record in place of the date of his birth, such age with express reference to the qualifying date shall be entered in like place on his national identification card.

  - "(3) Notwithstanding anything to the contrary in paragraph (1) a claimant referred to in regulation 23(1)(a) who had not made an application shall deliver his submission to the registration officer and at the time of delivery do all such things as are required of a person making application to a registration officer in accordance with regulation 6 and the provisions of that regulation and of regulation 7 shall, subject to the effect of the decision on the submission apply <u>mutatis mutandis</u> in respect of anything to be done by the claimant by virtue of this paragraph.

"Replacement of identification cards. 41.(1) The Commissioner shall issue a national identification card (hereinafter called a replacement national identification card) to replace a national identification card issued to any registered person if any particulars appearing in his registration record as a result of any change of or in his registration under these Regulations vary from particulars which were entered in the national identification card to be replaced or if upon the registered person's record it is shown to the satisfaction of the Commissioner that such card had been lost, destroyed, or damaged or does not conform to the requirements of regulation 20(a) and (b):

Provided that an omission from such card in contravention of those requirements may be provided by the Commissioner upon submission of the card to him by the person to whom it was issued.

- (2) An application for a replacement of a national form R 0.5 identification card under the preceding paragraph shall be in Form R 0.5.
  - (3) Where a national identification card issued to any person-
    - (a) has been lost, stolen, destroyed or damaged,mutilated or defaced; or
    - (b) is discovered to contain information given by such person which is inaccurate or incorrect,

he may apply to the registration office. of the area in which he resides for the replacement of the national identification card, and the registration officer, if he is satisfied that the application is a bona fide one, shall recommend the issue to that person of a replacement national identification card.

- (4) Whenever a registration officer recommends the replacement of a national identification card, he shall -
  - (a) forward to the Commissioner of Registration the original of Form R 05 of that person; and
  - (b) transmit, the national identification card if available to the Commissioner.
- (5) The Commissioner shall verify the information on Form R 05 before a new card is prepared for the registrant.
- (6) Whenever the Commissioner issues a replacement national identification card, he shall make or cause to be made an entry in the appropriate record showing the date of issue of the replacement national identification card and shall notify the appropriate registration officer of the issue of such card.

- (7) The registration officer shall cause an entry to be made in the duplicate of the registration record of person who receives the replacement national identification card.
- (8) A registration officer, on being satisfied as to the death of any person registered in his area to whom a national identification card was issued under these regulations, shall as soon as practicable after being so satisfied, require the representative of that person or any person in possession of the national identification card to surrender to him the national identification card that was issued to that person, if the registration officer is satisfied that it is within the power of any such person to do so.
- (9) On the expiry of a national identification card the holder shall apply for the renewal of such card in Form R 13.

destroyed or damaged original or duplicate of the registration record, as the case may be; and the Commissioner shall make and sign a certificate on the photocopy of the record to the effect that it is a true and correct reproduction.".


