Citation.

1. These Regulations, which amend the National Registration Regulations, may be cited as the National Registration (Amendment) Regulations 2005.

Amendment of regulation 2 of the Principal Regulations.

2. Regulation 2 (1) of the Principal Regulations is hereby amended by the substitution for the word "card", where it appears in the definition of "identity number", of the word "record".

Amendment of regulation 4 of the Principal Regulations.

3. Regulation 4 of the Principal Regulations is hereby amended by the substitution therefor of the following regulations –

"Registration of persons.

4.(1) Every person not resident in Guyana at the qualifying date, being a person to whom an order applies as mentioned in proviso (b) to section 6 (4), may accept the tender of the Registration Officer to be registered pursuant to such order in the manner prescribed by these Regulations.

(2) Every person making any such application as aforesaid shall –

- (a) furnish the particulars regarding himself as at the qualifying date which are required for the purposes of completion of Form NR 01;
- (b) furnish such documentary or other proof of any of the particulars referred to in subparagraph (a), including his birth certificate, as the Registration Officer may in any particular case reasonably require to satisfy himself of the truth thereof;

- (c) answer any questions which the Registration Officer may, in any particular case, reasonably consider necessary to put for the purpose of enabling him to decide whether the applicant is eligible to be registered.

and any requirement or question of the Registration Officer under the foregoing provisions of this paragraph may be notified or put by post to the applicant at his last known address.

(3) Every application under this regulation shall –

- Form NR 01.
- (a) be in Form NR 01;
 - (b) be in triplicate;
 - (c) be signed by the applicant;
 - (d) have a printed serial number,

and the applicant shall be classified therein as Category A in any case where his particulars are such as to qualify him for electoral registration as mentioned in section 14 (1), and as Category B in any other case.

(4) Notwithstanding anything to the contrary in paragraph (2) the registration record of any person cancelled pursuant to regulation 26 (1) (e) together with the duplicate and triplicate of such record shall be entertained by the Registration Officer as an application made pursuant to paragraph (1) by that person.

Investigation

4A. A Registration Officer may conduct an investigation into the facts set out in each application received by him for satisfying the residency and identity of the applicant.

4B. Where the Registration Officer is satisfied that the applicant is eligible to be registered, the Registration Officer shall prepare an application in triplicate in Form NR 01 to be signed by the applicant.

4C. (1) The Registration Officer shall, as soon as may be practicable, forward in the manner directed by the Commissioner the original and duplicate of registration records with photographs attached.

(2) On receipt of the documents referred to in paragraph (1), the Commissioner shall –

- (a) ensure that the particulars are validated before the information is encoded;
- (b) thereafter cause the national identification card to be produced; and
- (c) file the registration records as part of the official records.

(3) The national identification card in respect of each applicant shall be prepared by the Commissioner and shall bear his facsimile signature.

(4) Every national identification card shall bear a serial number and such other identification features necessary to identify the applicant as the person whom he claims to be, and such identification features may be

in the form of the applicant's facial photograph and facsimile signature or an imprint of the applicant's left thumb.

(5) The Commissioner shall issue a national identification card (hereinafter called a replacement national identification card) to replace a national identification card issued to any registered person.

Form NR 04. (6) An application for a replacement of a national identification card shall be in Form NR 04.

Form NR 04. (7) The Commissioner shall verify the information on Form NR 04 before a card is prepared for the registrant.

Form NR 11. (8) On the expiry of a national identification card the holder shall apply to renew same in Form NR 11.

Preparation of monthly list. 4D. The Registration Officer as directed by the Commissioner shall publish a monthly supplementary list of all the persons who make claims to entry in the preliminary list, changes or corrections of particulars and requests for transfer and post such lists in their respective offices and forward such lists to the Commissioner.

Merger of list to establish the preliminary list. 4E. The Commissioner shall within the prescribed time, direct the Registration Officer to merge the monthly supplementary lists with the official list which was used to commence continuous registration.

Preparation of preliminary list. 4F. The Commission shall direct the preparation of the preliminary list and the conduct of claims and objections in accordance with sections 14 and 15."

Revocation of regulation 5 of the Principal Regulations.

4. Regulation 5 of the Principal Regulations is hereby revoked.

Amendment of regulation 6 of the Principal Regulations.

5. Regulation 6 of the Principal Regulations is hereby amended as follows –

- (a) by the substitution in paragraph (1) for the word “card” of the word “record”;
- (b) by the substitution in paragraph (2) for the words “Form 2”, wherever they appear including the marginal note, of the words “Form NR05”;
- (c) by the insertion immediately after paragraph (2) of the following paragraph –

“(3) Any person who is aggrieved by the decision of the Registration Officer under paragraph (2) may deliver a notice of appeal, to the Commissioner on Form NR 06.

Amendment of regulation 7 of the Principal Regulations.

6. Regulation 7 of the Principal Regulations is hereby amended by the substitution for the word “card”, wherever it appears, of the word “record”.

Amendment of regulation 8 of the Principal Regulations.

7. Regulation 8 of Principal Regulations is hereby amended as follows –

- (a) by the substitution for the word “card”, wherever it appears, of the word “record”;
- (b) by the substitution in paragraph (1) for the words “Deputy Commissioner”, wherever they appear, of the words “Registration Officer”;
- (c) by the substitution of the words “Form 3”, wherever they appear including the marginal note, of the words “Form NR 02”;

(d) by the substitution for paragraph (3) of the following paragraph –

“(3) The Registration Officer may allow a claim made under paragraph (1) and, he shall cause the requisite alteration to the registration record and initial such alteration, and in the case of a change referred to in subparagraph (b) of that paragraph, he shall insert the date of such change.”;

(e) by the substitution in paragraph (4) for the words “Deputy Commissioner”, wherever they appear, of the words “Registration Officer”.

Amendment of regulation 9 of the Principal Regulations.

8. Regulation 9 of the Principal Regulations is hereby amended by the substitution therefor of the following regulation –

“Documents to be safely kept by Registration Officer.

9. (1) Regulations 15(1) and 19 of the National Registration (Residents) Regulations shall *mutatis mutandis* apply to the Registration Officer.

(2) The Commissioner may direct that all national identification cards, forms and other documents that have been received, completed or otherwise used by the Registration Officer, in the performance of his duties and all such documents which were required to be treated by him in the manner provided by the preceding paragraph shall be safely kept.”.

Amendment of regulation 11 of the Principal Regulations.

9. Regulation 11 of the Principal Regulations is hereby amended as follows –

- (a) by the substitution in paragraphs (1) and (2) for the words “Deputy Commissioner”, wherever they appear, of the words “Registration Officer”;
- (b) by the substitution for the words “Form 4”, “Form 5” and “Form 6” of the words “Form NR01”, “Form NR 03” and “Form NR 08” respectively.

Amendment of regulation 12 of the Principal Regulations.

10. Regulation 12 of the Principal Regulations is hereby amended by the substitution therefor of the following regulation-

“Submission of claims and objections.

12. (1) Every claim made under regulation 11 (1) and every objection made under regulation 11 (2) shall be submitted to the Registration Officer.

(2) A submission under the preceding paragraph may be made by tendering the claim or objection to the Registration Officer.

(3) Notwithstanding anything to the contrary in paragraphs (1) and (2) a claimant referred to in regulation 11 (1) (a) who had not made an application shall tender his submission to the Registration Officer and at the time of delivery do all such things as are required of a person making an application under regulation 4 and the provisions of paragraphs (2) and (3) of that regulation and of regulations 6 and 7 shall, subject to the effect of the decisions on the submission, apply *mutatis mutandis* in respect

of anything to be done by the claimant by virtue of this paragraph.”.

Amendment of regulation 13 of the Principal Regulations.

11. Regulation 13 of the Principal Regulations is hereby amended as follows –

- (a) by the substitution for the words “Deputy Commissioner, wherever they appear, of the words “Registration Officer”;

Amendment of regulation 14 of the Principal Regulations.

12. Regulation 14 of the Principal Regulations is hereby amended as follows –

- (a) by the substitution in paragraphs (1) and (2) for the words “Deputy Commissioner, wherever they appear including the marginal note, of the words “Registration Officer”;
- (b) by the substitution for paragraph (3) of the following paragraph –
“(3) When the Registration Officer allows any claim without holding a public enquiry he shall notify his decision to the Commissioner.”.

Amendment of regulation 15 of the Principal Regulations.

13. Regulation 15 of the Principal Regulations is hereby amended as follows –

- (a) by the substitution in paragraphs (1), (3), (4), (5), (6), (7) and (8) for the words “Deputy Commissioner”, wherever they appear including the marginal note, of the words “Registration Officer”;

- (b) by the deletion in the proviso to paragraph (1) of the words “or the Registration Officer”, in paragraph (4) of the words “or the Registration Officer” and in paragraph (8) of the words, “, before the Deputy Commissioner at a public enquiry, ”;
- (c) by the substitution in paragraph (2) for the words “Form 10”, wherever they appear including the marginal note, of the words “Form NR 10”; for the words “Deputy Commissioner”, where they appear for the first time, of the words “Registration Officer” and where they appear for the third time, of the word “Commissioner”.

“(2) The Registration Officer shall cause such notice of appeal to be forwarded to the Commissioner and a copy thereof to be served, forthwith upon receipt thereof at the Registration Officer’s office or Deputy Commissioner’s office, on the opposite party or his proxy.”;

- (c) by the deletion in paragraph (3) of the words “accompanied by a deposit of ten dollars and may be” and by the substitution for the words “Deputy Commissioner” of the words “Registration Officer”.
