THE NATIONAL INSURANCE AND SOCIAL SECURITY ACT

(Cap. 36:01)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTIONS 12, 14, 20, 21, 23, 24, 39 and 51, I HEREBY MAKE THE FOLLOWING REGULATIONS :---

1. These Regulations which amend the National Insurance Citation and and Social Security (Industrial Benefit) Regulations* may be cited commenceas the National Insurance and Social Security (Industrial Benefit) (Amendment) Regulations 1978 and shall come into operation on 14th Augest, 1978.

2. Regulation 2 (1) is hereby amended in the following Amendment respects —

(a) by the deletion of paragraph (b) of the proviso to the princidefinition of "relevant wage"; and

(b) by the deletion of "(a)" appearing in that proviso.

3. Part I of the First Schedule to the Principal Regulations Amendment is hereby deleted and the following Part substituted therefor — the First
