THE NATIONAL REGISTRATION ACT

(Cap. 19:08)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 19 OF THE NATIONAL REGISTRATION ACT, I HEREBY MAKE THE FOLLOWING REGULATIONS:—

1. These Regulations which amend the National Registration (Residents) Regulations^{*} may be cited as the National Registration (Residents) (Amendment) Regulations 1978.

2. Regulation 7 (1) of the Principal Regulations is hereby amended by the substitution for the full stop of a colon and by the insertion immediately thereafter of the following proviso -

"Provided that the divisional registrar, on being so satisfied in respect of an application by a person whose registration was cancelled pursuant to regulation 38, shall, notwithstanding anything to the contrary in these Regulations, in lieu of causing a registration card and an identification card to be prepared for

such person, treat such cards as were subject to cancelment under the said regulation as being prepared, pursuant to this regulation in respect of the said application and accordingly, subject to any amendments as the Commissioner considers necessary to make to such cards to have them conform to the particulars of the person concerned as are disclosed in his application to have occurred since the date of their preparation, the provisions of these Regulations shall apply mutatis mutandis^{**}.

3. Paragraph (1) of Regulation 9 of the Principal Regulations is hereby amended in the following respects —

- (a) by the substitution for the full stop appearing at the end thereof, of a colon; and
- (b) by the insertion as a proviso to that paragraph of the following —

"Provided that in respect of a registrant to whom the proviso to regulation 7 (1) applies, the foregoing requirements relating to him shall not apply".

4. Regulation 38 of the Principal Regulations is hereby amended in the following respects —

(a) by the relettering of paragraph (1) (e) as paragraph (1) (f) and the insertion immediately after sub-paragraph (d) of the following sub-paragraph —

"(e) the registrar is satisfied, upon the coming into operation of an order as mentioned in regulation 14(1), that such person would, but for such registration, be eligible to seek registration under that order."; and

(b) by the insertion in paragraph (6) immediat ly after the word "shall" of the words, "unless he is required pursuant to regulation 7 (1) to treat the card in the manner mentioned therein,",

5. The Schedule to the Principal Regulations is hereby amended by the insertion in Form 1 thereof, immediately aside of the words "Are you a deaf mute?." of the words "Were you previously registered (if so give particulars)"
