### REGULATIONS

#### MADE UNDER

# THE LABOUR ORDINANCE, (Chapter 103).

UNDER SECTION 35 OF THE LABOUR ORDINANCE IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR:—

- 1. These Regulations may be cited as the Hours of Work (Cinema Employees) Regulations, 1966, and shall be construed and read as one with the Hours of Work (Georgetown and New Amsterdam Cinema Employees) Regulations\*, hereinafter referred to as the Principal Regulations, and any Regulations amending the same.
- 2. The heading to the Principal Regulations is hereby amended by the deletion therefrom of the words "Georgetown and New Amsterdam".
- 3. Regulation 1 of the Principal Regulations is hereby amended by the deletion therefrom of the words "Georgetown and New Amsterdam".
  - 4. Regulation 2 of the Principal Regulations is hereby amended--
    - (a) by the deletion of the definitions of the expressions "First Run Cinema" and "Second Run Cinema";
    - (b) by the insertion immediately after the definition of the expression "general staff" of the following definitions—
      "Group A Cinema", means any cinema in the City of Georgetown as defined in section 4 of the Georgetown Town Council Ordinance (excluding any cinema in the said City south of Sussex Street) and any cinema in the Mackenzie area situate on the right bank of the Demerara River commencing from the Kara-Kara River and extending up the left bank of the Kara-Kara River to the Shibaru Creek thence up the left bank of the Shibaru Creek to its source and thence in a straight line due west to the right bank of the Demerara River at Three Friends:

"Group B Cinema" means any cinema in the town of New Amsterdam as defined in section 6 of the New Amsterdam Town Council Ordinance, any cinema in the City of Cap. 161. Georgetown south of Sussex Street or situate within one mile of the boundaries of the City of Georgetown as defined in section 4 of the Georgetown Town Council Ordinance;".

5. Regulation 8 of the Principal Regulations is hereby revoked and the following regulations substituted therefor —

### "8. These Regulations shall apply —

- (a) to the City of Georgetown as defined in section 4 of the Georgetown Town Council Ordinance, and the area within one mile of the boundaries thereof, and the Mackenzie area situate on the right bank of the Demerara River commencing from the Kara-Kara River and extending up the left bank of the Kara-Kara River to the Shibaru Creek thence up the left bank of the Shibaru Creek to its source and thence in a straight line due west to the right bank of the Demerara River at Three Friends:
- (b) to the town of New Amsterdam as defined in section 6 of the New Amsterdam Town Council Ordinance." Cap. 161.
- 6. The Principal Regulations are hereby amended by the substitution for the first schedule thereto of the schedule to these Regulations.
