REGULATIONS

MADE UNDER

THE RICE MARKETING ORDINANCE (Chapter 249)

UNDER SECTION 38 OF THE RICE MARKETING ORDINANCE THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE BRITISH GUIANA RICE MARKETING BOARD WITH THE APPROVAL OF THE MINISTER:—

- 1. These Regulations may be cited as the Rice Factories (Records and Accounts) (Amendment) Regulations, 1966, and shall be construed and read as one with the Rice Factories (Records and Accounts) Regulations*, hereinafter referred to as the Principal Regulations, and any Regulations amending the same.
- 2. At the end of Regulation 3 of the Principal Regulations the following paragraphs shall be added
 - "(5) an account book with numbered triplicate account forms, in accordance with Form 7 of the schedule, from which he shall issue statements of expenses payable to him by the owner of each consignment of rice delivered in compliance with section 12(1) of the Ordinance duly signed by him and the owner of the consignment:
 - (6) a receipt book with numbered duplicate receipt forms, in accordance with Form 8 of the schedule, from which he shall issue receipts in respect of padi received into the factory having been purchased from the owners thereof but the price of which has not been fully paid;
 - (7) a receipt book with numbered duplicate receipt forms, in accordance with Form 9 of the schedule, from which he shall issue receipts for padi received in his factory in exchange for rice for domestic consumption."
- 3. At the end of Form 6 of the schedule to the Principal Regulations the forms contained in the schedule to these Regulations shall be added.
