REGULATIONS

MADE UNDER

THE SUGAR INDUSTRY SPECIAL FUNDS ORDINANCE
(CHAPTER 248)

UNDER SECTION 9(1) OF THE SUGAR INDUSTRY SPECIAL FUNDS ORDINANCE, THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE COMMITTEE APPOINTED TO CONTROL AND ADMINISTER THE SUGAR INDUSTRY LABOUR WELFARE FUND, WITH THE APPROVAL OF THE ACTING GOVERNOR GENERAL BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF.

1. These Regulations may be cited as the Sugar Industry (Labour Welfare Fund) (Amendment) Regulations, 1968, and shall be construed and read as one with the Sugar Industry (Labour Welfare Fund) Regulations, hereinafter referred to as the Principal Regulations.

2. Regulation 13 of the Principal Regulations is hereby amended by the substitution of the words "at such time in every year as the Committee may deem fit" for the words "once in every year" and by the substitution of the words "or to any special account established in accordance with these Regulations and in such proportions or in any other manner as the Committee may in its discretion decide" for the words "in such proportions as the Committee may deem fit".

3. Regulation 17(4) of the Principal Regulations is hereby amended as follows:—

- (a) By the substitution of the words "may in its discretion" for the word "shall"
- (b) By the insertion of the word "either" after the word "made"
- (c) By the deletion of the full stop after the word "employed" and the addition thereto of the words "or to any special account established as herein provided."

4. The Principal Regulations are hereby amended by the insertion after Regulation 17 of the following part —

"17(5). Notwithstanding anything to the contrary contained in these Regulations, the Committee may —

- (a) authorise the establishment of one or more special accounts under such description or designation as the Committee may deem fit;
- (b) authorise at any time or from time to time the transfer to any special account established as herein provided any part or portion of any amount standing at the credit of any Exporter's allocation or account in the Fund.

- (c) authorise the disbursement for any particular or general purpose authorised by these Regulations, and irrespective of any Exporter, sugar estate or labour worker concerned therewith, of all or any part of the amount at credit of any special account established as herein provided.
