GUYANA

REGULATIONS

MADE UNDER

THE NATIONAL REGISTRATION ACT, 1967, (No. 24 of 1967).

UNDER SECTION 19 OF THE NATIONAL REGISTRATION ACT, 1967, THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE MINISTER :--

1. These Regulations may be cited as the National Registration (Residents) (Revision of Registers) (No. 2) Regulations, 1969, and shall be construed with the National Registration (Residents) (Revision of Registers) Regulations, 1969*, hereinafter referred to as the Principal Regulations, and all amendments thereto.

2. Notwithstanding anything to the contrary provided by or under the National Registration (Residents) Regulations, 1967**, the dates prescribed by these Regulations shall, for the purposes of the Principal Regulations, be the dates with reference to which the acts mentioned in these Regulations shall be respectively performed.

3. Claims in respect of entries in preliminary lists shall be sent to the registrar of the district so as to be received by him not later than the 14th July, 1969, and objections in respect of entries in such lists shall be sent to the registrar of the district so as to be received by him not later than the 28th July, 1969.

- 4. Every registrar shall -
 - (a) on the 17th July, 1969, cause a list of the claims received by him under the last preceding regulations; and
 - (b) on the 31st July, 1969, cause a list of the objections received by him under the last preceding regulation and a notice of the commencement of the public enquiry mentioned in regulation 5 of these Regulations,

to be affixed to each of not less than two buildings determined by him in every registration division in his district.

(1) Subject to the provisions of paragraph (2) of this regulation, every registrar shall hold a public enquiry which shall commence not later than the 5th August, 1969, at which claims and objections duly submitted to, and received by, him in pursuance of these Regulations shall be investigated and determined.

(2) Every registrar may, without holding a public enquiry, allow claims submitted to him if —

(a) no notice of objection thereto has been submitted; and

(b) he is satisfied that the claim may be duly allowed.

(3) When a registrar allows any claim without holding a public enquiry he shall notify his decision to the Commissioner.

6. Regulations 23, 24, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 43, 44, 45, 47 and 48 of the National Registration (Residents) Regulations, 1967**, shall apply *mutatis mutandis* to the revision of the central and divisional registers by virtue of the National Registration (Residents) (Revision of Registers) Regulations, 1969*, as they apply for the purpose of the registration of persons under the first-mentioned regulations, subject to the following modifications —

- (a) the substitution for the words and figures "paragraph (1) of regulation 25" in paragraph (2) of regulation 24 of the word and figure "regulation 3";
- (b) the substitution for the word and figures "regulation 26" in paragraph (7) of regulation 27 of the word and figure "regulation 5".

7. The forms prescribed by the National Registration (Residents) Regulations, 1967**, for use in connection therewith shall for the purposes of these Regulations, be used with all necessary variations, modifications and adaptations.
