THE FISHERIES ORDINANCE, 1956. (No. 30 of 1956)

- UNDER SECTION 33 OF THE FISHERIES ORDINANCE, 1956, THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE MINISTER FOR THE TIME BEING CHARGED WITH RESPONSIBILITY FOR FISHERIES:
- 1. These Regulations may be cited as the Fisheries (Amendment) Regulations, 1969, and shall be construed and read as one with the Fisheries Regulations, 1957, hereinafter referred to as the Principal Regulations, and any Regulations amending the same.
- 2. The following paragraph is hereby substituted for paragraph (2) of regulation 4 of the Principal Regulations
 - "(2) Every licence issued under this regulation shall be in the appropriate form set out as Form No. 4 or Form No. 4A in the first schedule."
 - 3. Regulation 5 of the Principal Regulations is hereby revoked.
- 4. Regulation 6 of the Principal Regulations is hereby amended in the following respects
 - (a) by the deletion of the word "for a period" of twelve months from the date of issue" in paragraph (3) and the substitution therefor of the words "for the period of one year commencing on the 1st January, in every year";
 - (b) by renumbering paragraphs (4), (5) and (6) as paragraphs (5),
 (6) and (7) respectively, and the insertion of the following paragraph as paragraph (4) —

- "(4) Where at any time during the period referred to in paragraph (3) of this regulation, a new permit is issued for the first time it shall expire on the 31st December in the year in which it is issued but no proportionate reduction in the annual fee payable for the permit shall be allowed."
- 5. (1) The form set out in the first schedule to these Regulations is hereby substituted for Form No. 4 in the first schedule to the Principal Regulations.
- (2) The forms set out in the second schedule to these Regulations are hereby inserted as Forms No. 4A and No. 4B in the first schedule to the Principal Regulations.
- 6. Form No. 5 in the first schedule to the Principal Regulations is hereby amended by the deletion therefrom of the words "for a period of twelve months from the date hereof" and the substitution therefor of the words and figures "until the 31st December, 19....".
- 7. The first schedule to the Principal Regulations is hereby amended by the substitution of the number "19...." for the number "195" wherever the latter number appears in the forms contained therein.

"Licence for a person to fish \$0.25

- Licence authorising the registered owner of a trawler exceeding 50 feet in length to engage in fishing with the said trawler ... \$100.00
- Licence authorising the registered owner of a fishing boat other than a trawler exceeding 50 feet in length to engage in fishing with the said boat ... \$10.00'
- 9. The Principal Regulations are hereby amended in the following respects --
 - (a) the expression "Chief Agricultural Officer" shall be substituted for the word "Director" wherever it appears;
 - (b) the word "Minister" shall be substituted for the expression "Governor in Council" wherever it appears.
- 10. Anything lawfully done under the Principal Regulations prior to their amendment by these Regulations and which would continue to have effect but for such amendment, shall continue to have effect as if so done in conformity with such amendment:

Provided that any permit issued under regulation 6 of the Principal Regulations prior to the commencement of these Regulations and which is expressed to remain in force for a definite period shall not remain in force after the expiration of that period, but the provisions of paragraph (4) of regulation 6, of the

Principal Regulations as amended by these Regulations, shall apply mutatis mutandis to the renewal of that permit as they apply in relation to the issue of a new permit.
