## REGULATIONS TO AMEND THE POST OFFICE (PAYMENT FOR OVERTIME) REGULATIONS, 1936.

1. These Regulations may be cited as the Post Office (Payment for Overtime) (Amendment) Regulations, 1939, and shall be construed with the Post Office (Payment for Overtime) Regulations, 1936, hereinafter referred to as the Principal Regulations, and any Regulations amending the same. Short title.

2. Schedule II to the Principal Regulations is hereby amended by deleting the following words and figures in sub-paragraph (a) of paragraph 1— Amendment of Schedule II to the Principal Regulations.

“ Letter carriers	\$1 00
Apprentices	2 00 ”

and by substituting the following therefor :—

“ Letter carriers	2 00
Apprentices	3 00 ”

3. Schedule VI to the Principal Regulations is hereby amended— Amendment of Schedule VI to the Principal Regulations.  
(a) by repealing paragraph 1 and substituting the following therefor :—

“Definition. 1. In this Schedule, unless the context otherwise requires—

“ Normal working hours ” means eight actual working hours on the week days, Monday to Friday inclusive, and five hours on Saturdays, public holidays excepted ” ;

- (b) by inserting the words “and persons temporarily employed on duties of such officers and employees” between the words “salaries” and “may” in the fifth line of paragraph 2 ;
- (c) by deleting the words “the Senior Wireless Operator” in the second line of paragraph 5 ;
- (d) by inserting the words “Messengers stationed in country districts” between the words “Georgetown” and “Wireless Operators” in the fourth line of paragraph 5 ;
- (e) by repealing sub-paragraph (a) of paragraph 7 and by substituting the following therefor :—

“(a) Overtime work on week days shall be paid for at the rates specified in paragraph 2 of this Schedule. It shall be paid monthly on the basis of a 45 hour week, that is, 8 hours daily from Monday to Friday inclusive and 5 hours on Saturdays. Officers or employees on leave during part of any week may for the absent period be credited with 8 hours for each week day (Monday to Friday inclusive) and 5 hours on Saturdays in computing any overtime claimed by them for that week.”

4. These Regulations shall take effect as from the first day of January, 1939.
