REGULATIONS RESPECTING THE REGISTRATION OF MONEY-LENDERS AND MATTERS IN CONNECTION THEREWITH.

- 1. These Regulations may be cited as the Money-lenders (Regis- Short title. tration) Regulations, 1938.
 - 2. In these Regulations and the Schedules hereto—

Interpre-

- "the Registrar" means the Registrar of Deeds;
- "the Registry" means the deeds registry.
- 3.—(1) The fees set out in the First Schedule hereto shall be charged and taken in the Registry and recovered by the Registrar in respect of the various matters specified therein.
 - (2) All fees shall be payable in advance.
- 4. The forms set out in the Second Schedule hereto shall be used Forms. in respect of the matters therein provided for.
- 5. Individuals, firms, societies or companies proposing to com-Obligation mence the business of money lending must register before doing so. to register.
- 6. A change of any kind in a firm or unincorporated society or company, or in its place or places of business, as also a change in the place or places of business of any incorporated society, company change in

any of particulars registered.

or individual, shall entail a fresh registration which must be made within one calendar month of such change.

Renewal of registration after 3 years. Cap. 68.

7. At the expiration of 3 years from the date of the preceding registration for which period registration is under section 5 (2) of the Money-lenders Ordinance effective, one calendar month shall be allowed for a renewal of the registration.

How registration effected.

8. The registration shall be effected either by post or by personal attendance at the Registry in Georgetown.

Returns to be kept in alphabetical order. 9. In the Registry the actual returns shall be kept in files in alphabetical order so that the public may readily inspect any or every return.

Alphabetical index to be kept in registry.

 ${\bf 10}.$ In the Registry an alphabetical index shall be kept of all money-lenders who have made returns for registration.

Copy of particulars registered to be sent to District Commissioner. 11. Immediately upon the receipt of a return of particulars for registration the Registrar shall forward a copy thereof certified under his hand and seal to the District Commissioner in whose district the money-lender's business is carried on.

District Com missioner to keep alphabetical index of copies of returns. 12. In each office of a District Commissioner an alphabetical index shall be kept of all the copies of returns forwarded thereto from the registry.

Register and returns hitherto kept by Chief Commissary to be transmitted to Registrar.

13. The District Commissioner, West Demerara, shall transmit to the Registrar the register of money-lenders hitherto kept by him as Chief Commissary and the returns furnished to him under the Money-lenders Registration Regulations, 1912.

Revocation and saving clause.

14. The Money-lenders Registration Regulations, 1912, are hereby revoked.

Provided however that a registration effected before these regulations come into force shall continue to have operation subject to the provisions of regulations 6 and 7 hereof.
