REGULATIONS

MADE UNDER

THE EDUCATION ORDINANCE (Chapter 196).

UNDER SECTION 57 OF THE EDUCATION ORDINANCE THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR IN COUNCIL:—

- 1. These Regulations may be cited as the Education Code (Amendment No. 2) Regulations, 1947, and shall be construed with the Education Code, 1940,* hereinafter referred to as the Code.
- 2. Sub-regulation (6) of regulation 30 of the Code as substituted by regulation 3 of the Education Code (Amendment) Regulations, 1946,** is hereby amended—
 - (a) by the deletion of the words "except in special circumstances" where they appear in the proviso thereto; and
 - (b) by the insertion of the words "except in special circumstances" after the words "Provided that" in the said proviso.
- 3. Regulation 33 of the Code, as substituted by regulation 3 of the Education Code (Amendment) Regulations, 1946, is hereby amended by the addition thereto of the following sub-regulations—
 - "(6) A first assistant teacher on leave in any school year for a continuous period exceeding fourteen days shall not be paid the allowance for such period.
 - (7) A certificated assistant teacher appointed to act as a first assistant teacher in any school year for a continuous period exceeding fourteen days shall be paid an allowance at the rate of \$10 a month for such period. No allowance will be paid in respect of an acting appointment for a period which does not exceed fourteen days."
- 4. Regulation 34 of the Code, as substituted by regulation 3 of the Education Code (Amendment) Regulations,

1946, is hereby revoked and the following regulation is substituted therefor—

"Certificated teachers acting as head teachers.

- 34. (1) In any school year a first assistant teacher appointed to act as head teacher for more than fourteen days continuously at any one period shall receive a responsibility allowance at the rate of \$15 a month in addition to his salary as an assistant teacher and his first assistant's allowance if any.
- (2) In any school year a certificated assistant teacher (other than a first assistant teacher) appointed to act as head teacher for more than 3 days continuously at any one period shall receive a responsibility allowance at the rate of \$15 a month in addition to his salary as an assistant teacher.
- (3) A first assistant or certificated assistant teacher appointed to act as head teacher shall receive any expenses necessarily incurred in travelling to and from the school in which he is acting as head teacher.
- (4) A certificated assistant teacher appointed to take charge of a branch school shall be paid at the rate prescribed for a certificated assistant teacher together with a responsibility allowance of \$10 a month."
- 5. Sub-regulation (1) of regulation 37 of the Code as substituted by regulation 3 of the Education Code (Amendment) Regulations, 1946, is hereby amended by the insertion of the following after the word "over" in paragraph (c) thereof—

"prior to the 31st December, 1945"

6. Regulation 86 of the Code is hereby revoked and the following regulation is substituted therefor—

"Inspection,

- 86. (1) Every school shall be inspected from time to time for the purpose of determining its state of efficiency.
- (2) Where a school is classified under regulation 88 as "poor" or "unsatisfactory" the teachers (other than teachers who have reached the

maximum salaries of their grades) who in the opinion of the Director are responsible for the loss of efficiency shall be warned that their future increments may be stopped after the next inspection. Such a school shall be inspected again within twelve months and if the school is again classified as "poor" or "unsatisfactory" the teachers who in the opinion of the Director are responsible for the loss of efficiency shall not be given any further increments until at some future inspection the school ceases to be so classified.

- (3) When a teacher has reached the maximum salary of his grade and on inspection the normal efficiency of his school, division or class has not been maintained, he shall be warned that his salary may be reduced after the next inspection. Such a school, division or class shall be inspected again within twelve months, and if the school, division or class is still below its normal efficiency there shall be deducted each month from the salary of such teacher a sum equivalent to his last increment until at some future inspection the school, division or class regains its normal efficiency.
- (4) The Director may, at any reasonable time, inspect all books prescribed to be used in connection with the school."
