# REGULATIONS

# MADE UNDER

THE LABOUR ORDINANCE, 1942,

'(No. 2 of 1942).

UNDER SECTION 40 (d) OF THE LABOUR ORDINANCE, 1942, THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR IN COUNCIL.

1. These Regulations may be cited as the Labour (Statistics) Regulations, 1953.

2. In these Regulations—

"cinema" means any place where exhibitions of a public nature are given of pictures or other optical effects by means of a cinematograph or similar apparatus; "Commissioner" means the Commissioner of Labour;

"drug store" means any place or premises required to take out a licence under section 20 or section 21 of the Tax Ordinance, 1939;

"dry goods store" means any place or premises used solely or mainly for the sale of dry goods either by way of wholesale or retail trade;

"employee" means any person employed in any of the businesses specified in the First Schedule to these Regulations whose wages have been prescribed by Order made under section 8 of the Labour Ordinance, 1942;

"employer" means any person carrying on any of the businesses specified in the First Schedule to these Regulations, and includes the manager or person for the time being in charge of any such business;

"grocery" means any place or premises used solely or mainly for the sale of groceries;

"hardware store" means any place or premises used solely or mainly for the sale of furniture, hardware or ironmongery either by way of whole sale or retail trade;

"quarter" means the period of three months ending 31st March, 30th June, 30th September, 31st December in any year.

3. Every employer shall send to the Commissioner within fourteen days of the end of each quarter a return of employees in the appropriate form set out in the Second Schedule to these Regulations.

4. Any employer who contravenes or fails to comply with any of these Regulations shall be liable on summary conviction to a penalty not exceeding one hundred and fifty dollars.

5. These Regulations shall come into force on the first day of July, 1953.
