UNDER SECTION 18 OF THE SPECIAL REVISAL ORDINANCE, 1956, THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR IN COUNCIL:—

- These Regulations may be cited as the Special Revisal (Variation of Forms) Regulations, 1957.
- The forms prescribed in the first schedule to the Special Revisal Ordinance, 1956, shall be varied in the following manner:—
 - (a) for Form No. 3 there shall be substituted the form prescribed in Part I of the schedule to these Regulations;
 - (b) in Form No. 6, the schedule thereto shall be in the form set out in Part II of the schedule to these Regulations;
 - (c) in Form No. 7, the schedule thereto shall be in the form set out in Part III of the schedule to these Regulations;
 - in Form No. 8, for the words "registration officer" in item (b) of (d) the marginal notes there shall be substituted the words "revising officer"; and
 - in Form No. 10, for the word "district" after the words "for the (e) said" there shall be substituted the word "areas".
