(Chapter 196).

UNDER SECTION 83 OF THE MINING ORDINANCE THE FOL-LOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR IN COUNCIL:—

Short title.

1. These Regulations may be cited as the Mining (Amendment) Regulations, 1961, and shall be construed and read with the Mining Regulations*, as amended from time to time, hereinafter referred to as the Principal Regulations.

Amendment to paragraph (1) of regulation 6. 2. Paragraph (1) of regulation 6 of the Principal Regulations is hereby amended by the deletion of the words person authorised by him" therein and by the substitution therefor of the words "other person who is authorised by him and who acknowledges such authorisation,"

Amendment to the first schedule to the Principal Regulations.

3. Form 2 in the first shedule to the Principal Regulations is hereby amended by the insertion between the two existing lines for signatture therein of the following words and line:

"I acknowledge this

authorisation.

(Signed)

The Person Authorised"

4. The first schedule to the Principal Regulations as amended by the Mining (Amendment) Regulations 1954**, is hereby further amended by the deletion of Forms 3 and 3A appearing therein and the substitution therefor respectively of the forms set out in the schedule to these Regulations.
