# THE REPRESENTATION OF THE PEOPLE ORDINANCE, 1957, (No. 3 of 1957).

UNDER SECTION 112 OF THE REPRESENTATION OF THE PEOPLE ORDINANCE, 1957, AND BY VIRTUE OF ALL POWERS ENABLING HIM IN BEHALF, THAT THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR IN COUNCIL :--

Short title. 1. These Regulations may be cited as the Representation of the People (Amendment) Regulations, 1961, and shall be construed and No. 7 of 1957. read with the Representation of the People Regulations, 1957, hereinafter referred to as the Principal Regulations, and any Regulations amending the same.

and shall with all convenient speed deliver the packets to the returning officer, together with the ballot box duly sealed by the presiding officer.

The packets shall be accompanied by a statement (2) (in these Regulations referred to as "the ballot paper account") made by the presiding officer showing the number of ballot papers entrusted to him, and accounting for them under the heads of ballot papers in the ballot box, unused, spoiled and tendered ballot papers.

(3) If any presiding officer shall omit to carry out any of the requirements of this regulation he shall, in addition to any other punishment to which he may be liable, forfeit all right to payment for his services as such officer."






