THE ELECTORAL PROVISIONS (REGISTRATION) ORDINANCE, 1961,

(No. 10 of 1961).

UNDER PARAGRAPH (c) OF SECTION 23 OF THE ELEC-TORAL PROVISIONS (REGISTRATION) ORDINANCE, 1961, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE GOVERNOR:---

1. These Regulations may be cited as the Electoral Provisions (Registration) (No. 2) Regulations, 1962.

2. Rule 20 of the Rules is hereby amended by the insertion therein of the following new paragraphs —

"(3) Notwithstanding the provisions of these Rules the electoral registrar upon completion of the revision of the preliminary list as hereinbefore provided in this Part of these Rules, shall, if so directed by the Chief Electoral Officer, forward to him such list as revised certified in the form set out as Form No. 5 in the second schedule together with a statement in the form set out as Form No. 14 in the second schedule of all changes and additions made to the list by him and all previous changes and additions made to it, and shall affix a copy of such list certified in like manner and a copy of such statement to one building in the polling division to which the preliminary list relates.

(4) Upon receipt of the preliminary lists and statements in accordance with the provisions of the immediately preceding paragraph the Chief Electoral Officer shall cause a supplementary register for each electoral district to be printed as expeditiously as possible.

(5) When printed the supplementary register for each electoral district shall contain all such changes and additions to the preliminary lists for the polling divisions of such electoral district as have been previously made and as are not affected by the revision together with all other changes and additions made to the said preliminary lists by the electoral registrar and shall be certified accordingly by both the electoral registrar and the Chief Electoral Officer in Form No. 15, the form set out as Form No. 15.

(6) When the supplementary register for an electoral district has been certified in accordance with the provisions of the immediately preceding paragraph such supplementary register shall together with the preliminary lists for the polling divisions of such electoral district constitute the register required by section 7 of this Ordinance to be in existence for such electoral district."

3. The Rules are hereby amended by the insertion therein after rule 25 of the following rule —

"26. In these rules —

"supplementary register" means in respect of any electoral district the supplementary register prepared in accordance with rule 20."

4. Form No. 14 and Form No. 15 in the schedule to these Forms Nos. Regulations are hereby inserted as such in the second schedule to the ¹⁴ and ¹⁵ second Electoral Provisions (Registration) Ordinance, 1961.
