THE CINEMATOGRAPH AND VIDEO ACT
(Cap. 21:02)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER
BY SECTION 10 OF THE CINEMATOGRAPH AND VIDEO ACT, I
HEREBY MAKE THE FOLLOWING REGULATIONS:—

1. These Regulations, which amend the *Cinematograph
Regulations, may be cited as the Cinematograph and Video
(Amendment) Regulations 1987. Citation.

2. Regulation 1 of the Principal Regulations is hereby
amended by the insertion after the word "Cinematograph" of
the words "and Video". Amendment
of regulation
1 of the
Principal
Regulations.

3. Regulation 2 of the Principal Regulations is hereby
amended as follows — Amendment
of regulation
2 of the
Principal
Regulations.

(a) in the definition of "new building", by the sub-
stitution for the words "Cinematograph exhibi-
tions," of the words "cinematograph or video ex-
hibitions;"

(b) by the insertion at the end of the following def-
inition —

“video exhibition” means —

(a) any exhibition to which the Act applies;
and

(b) any public exhibition of any video tape
in any video centre.’

Insertion of regulation 3A in the Principal Regulations.

4. The Principal Regulations is hereby amended by the insertion after regulation 3 of the following regulation as regulation 3A —

3A.(1) No new building shall be used as video centre for video exhibitions unless it is provided with an adequate number of exits clearly indicated and so placed and maintained as readily to afford the audience ample means of safe egress.

(2) Every video centre shall be provided with sufficient and adequate means of escape in the event of fire, subject to the satisfaction of the Chief Fire Officer in the case of Georgetown or the fire officer in charge of Fire Service Unit elsewhere.”.

Amendment of regulation 5 of the Principal Regulations.

5. Regulation 5(1)(b) of the Principal Regulations is hereby amended by the insertion after the word “theatre” of the words “or video centre”.

Amendment of regulation 32 of the Principal Regulations.

6. Regulation 32 of the Principal Regulations is hereby amended by the insertion after the words “section 11” and “cinematograph theatre” of the words “or section 11A” and “or video centre” respectively.

Amendment of regulation 33 of the Principal Regulations.

7. Regulation 33 of the Principal Regulations is hereby amended by the insertion after the word “theatre” wherever it occurs, of the words “or video centre”.

Amendment of regulation 35 of the Principal Regulations.

8. Regulation 35 of the Principal Regulations is hereby amended by the insertion after paragraph (3) of the following paragraph as paragraph (4) —

“(4) The provisions of this regulation shall apply in respect of every new building used as a video centre and licensed under section 11A of the Act.”.

Amendment of regulation 44 of the Principal Regulations.

9. Regulation 44 of the Principal Regulations is hereby amended by the insertion after the words “cinematograph film” of the words “or video tape”.

Amendment of regulation 45 of the Principal Regulations.

10. Regulation 45 of the Principal Regulations is hereby amended by the insertion after the word “apparatus” in both places where it occurs, of the words “or video set” and after the words “section 11” of the words “or section 11A”.
