THE CINEMATOGRAPH AND VIDEO ACT (Cap. 21:02)

- IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 10 OF THE CINEMATOGRAPH AND VIDEO ACT, I HEREBY MAKE THE FOLLOWING REGULATIONS:—
- 1. These Regulations, which amend the *Cinematograph Cttation. Regulations, may be cited as the Cinematograph and Video (Amendment) Regulations 1987.
