## **THIRD REPORT**

### **Introduction**

1. The Standing Committee established under the Constitution to address matters relating to the appointment of members of commissions, pursuant to Article 119C of the Constitution and under the provisions of Standing Order No. 84, has agreed to the following as the Third Report -

### **Members of the Committee**

2. At a meeting of the Committee of Selection held on 14<sup>th</sup> December, 2006, the following Members were nominated to the Committee on Appointments to address matters relating to the appointment of Members of the Commission:

#### **Members from the People's Progressive Party/Civic:**

### **Election of Chairman**

3. The Committee at its first meeting held on 21<sup>st</sup> December, 2006 unanimously elected Ms. Gail Teixeira, M.P. as its Chairperson.

### **Terms of Reference**

4. The Committee, by Resolution No. 17 passed by the National Assembly on 8<sup>th</sup> May, 2003, was entrusted to discharge the following functions in relation to the appointment of a member of the Commission established under the Constitution -

- “(a) identify appropriate bodies for consultation in the appointment of the relevant members of the Commission, conduct the necessary consultations with them and, where necessary, receive nominations from appropriate bodies;
  
- (b) make recommendations to the National Assembly
  - (i) for a consensual mechanism for the Ethnic Relations Commission, the Women and Gender Equality Commission, the Indigenous People’s Commission and the Rights of the Child Commission;
  - (ii) for the appointment of members of the Commissions with the exception of the Public Procurement Commission; and
  - (iii) in connection with any other matter referred to it by the National Assembly from time to time.
  
- (c) report to the National Assembly in relation to each Commission as soon as possible upon the discharge of its function in relation thereto.”

## **Mandate**

5. The Committee was mandated by Article 210 (1) (c) of the Constitution in relation to the Police Service Commission to nominate for appointment by the President:

*“four members appointed by the President upon nomination by the National Assembly after it has consulted such bodies as appear to it to represent the majority of the members of the Police Force and any other such body it deems fit:”*

## **POLICE SERVICE COMMISSION**

### **7.1 The Nomination Process**

7.1.1 The Committee received Resolution No. 35 which was passed by the National Assembly on 27<sup>th</sup> July, 2007.

7.1.2 The Resolution determined that the National Commission of Law and Order and the National Executive of the Community Policing Groups be among the bodies that appear as bodies the Committee deems fit to submit nominees to the Police Service Commission.

7.1.3 At the meeting held on 31<sup>st</sup> July, 2007, the Committee proceeded to implement the decision of the National Assembly in accordance with article 210 (1) (c) of the Constitution and considered the nominations it had received from the Police Association, the Association of Former Members of the Guyana Police Force, the National Commission on Law and Order and the National Executive of Community Policing Groups.

7.1.4 The Police Association and Association of Former Members of the Guyana Police Force had by letters dated March 12, 2007 and March 13, 2007, respectively had submitted the following nominees:

- (i) **Mr. Henry Chester, D.S.M.**, Retired Deputy Commissioner of Police
- (ii) **Mr. Ivan Crandon, D.S.M.**, Retired Deputy Commissioner of Police,
- (iii) **Mr. Harold Martin**, Retired Assistant Commissioner of Police, and
- (iv) **Mr. Franchot Duncan Clarke**, Retired Assistant Commissioner of Police.

7.1.5 The National Commission on Law and Order by letter dated May 22, 2007 submitted the following nominees:

- (i) **Mr. Dennis Morgan, A.A.**, Former Chairman of the Police Service Commission
- (ii) **Mr. Roshan Khan**, Chief Executive Officer/Founder of RK's Security Service

7.1.6 The National Community Policing Executive by letter dated July 3, 2007 had submitted the following nominees:

- (i) **Mr. Roopchand Jaigobind aka Kishore Gobin** - Chairman of the National Executive of the Community Policing Groups
- (ii) **Ms Pamela Mendonca** - Division A, Chairperson, Community Policing Groups.

7.1.7 The following proposals were made relating to the persons to be signified to the President for appointment to the Police Service Commission:

**Proposal 1 made by the PPP/C representatives:** Mr. Ivan Crandon, D.S.M., Mr. Harold Martin, Mr. Franchot Duncan Clarke, and Mr. Dennis Morgan, A.A.


**Proposal 2 made by the PNCR-IG representatives:** Mr. Henry Chester, D.S.M., Mr. Ivan Crandon, D.S.M., Mr. Harold Martin, and Mr. Franchot Duncan Clarke.

**Proposal 3 of the AFC representative:** Mr. Henry Chester, D.S.M., Mr. Harold Martin, Mr. Franchot Duncan Clarke and Mr. Dennis Morgan, A.A.

## 7.2 The Committee's Selection Process

7.2.1 The Committee in the examination of the names before it unanimously agreed to **Mr. Harold Martin**, and **Mr. Franchot Duncan Clarke**, being two of its nominees and by a majority vote, agreed to **Mr. Ivan Crandon, D.S.M.**, and **Mr. Dennis Morgan, A.A.**, as its third and fourth nominee, respectively, to the Police Service Commission.

7.2.2 The Committee now reports to the National Assembly that it has meaningfully consulted with the Police Association, the Association of Former Members of the Guyana Police Force, the National Commission on Law and Order and the National Executive of Community Policing Groups, bodies as appear to it to represent the majority of the members of the Police Force and any other such body it deems fit and recommends that **Mr. Ivan Crandon, D.S.M.**, **Mr. Harold Martin**, **Mr. Franchot Duncan Clarke**, and **Mr. Dennis Morgan, A.A.**, be signified as the Assembly's choice to the President for appointment as Members of the Police Service Commission.
